These officers have become an integral part of our school communities; attending student activities, speaking in classrooms or to groups of students, and they always having a presences that builds trust.

Our School Resource Officers play key roles in our emergency planning and can work with other agencies throughout a crisis to ensure all support services are utilized to their fullest capacity.

Our School Resources Officer are not used as a tool for student discipline. That responsibility is on administration. They do however, provide us with knowledge and insight to how to best prevent a student from encountering legal issues and can provide us with necessary support to ensure a successful outcome for our students and their family.
