## Extend Reward Offer for the "Smash and Grab" Incident at the Macy's in Rosemead

On Tuesday, September 5, 2023, five suspects entered the Macy's in the city of Rosemead. One suspect was carrying a metal rod (possibly a baseball bat) that he used to smash the glass display cases of perfume. Suspects stole multiple items, placing them in black trash bags, and exited the store. They entered a black Toyota Camry that had a stolen license plate affixed to it and was last seen entering the westbound 60 freeway.

The two display cases that were smashed resulted in approximately \$675 in damages. A total of 91 items were stolen totaling \$13,852.

To date, the Los Angeles County Sheriff's Department (LASD) have yet to make any arrests of the persons responsible and are seeking the assistance of the public for any information. LASD provided the following descriptions of the suspects:

1. Male, Black, 20-24 years of age, 5'11" to 6'0". Wearing a white hooded sweatshirt, black pants, white "Reebok" shoes, white mask, and yellow and

green gloves.

- 2. Male, Black, 20-24 years of age, 5'11" to 6'0". Wearing a black hooded sweatshirt, grey pants, "Nike Air Force" shoes, black mask, and black gloves.
- 3. Male, Black, 20-24 years of age, 5'11" to 6'0". Wearing a brown hooded sweatshirt, dark blue jeans, white shoes, and a blue mask.
- 4. Male, Black, 20-24 years of age, 6'2". Wearing a black hooded sweatshirt, black pants, black and white shoes, black mask, and white gloves.
- 5. Male, Black, 20-24 years of age, 5'8". Wearing a grey "Nike" hooded sweatshirt, ripped black pants, black mask, and blue gloves.

On September 12, 2023, the Board of Supervisors approved the motion by Supervisor Hilda L. Solis to establish a \$15,000.00 reward in exchange for information leading to the arrest and conviction of the persons responsible for the heinous damage and destruction of display cases, and theft of property that occurred at Macy's at Rosemead on September 5, 2023. On December 5, 2023 the Board of Supervisors extended the reward and is set to expire on August 8, 2024. Though this reward has been extended before, investigators still believe a reward would be appropriate in this case, and hope that by extending the reward, witnesses with information will be motivated to come forward to help apprehend and convict the suspect(s) responsible for the heinous damage and destruction of display cases, and theft of property in this case.

I, THEREFORE, MOVE that the Board of Supervisors extend the reward

previously offered in the amount of \$15,000.00 in exchange for information leading to the arrest and conviction of the persons responsible for the heinous damage and destruction of display cases, and theft of property that occurred at Macy's at Rosemead on September 5, 2023.
