### **RESOLUTION NO. 24-30**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF NORWALK CALLING FOR THE HOLDING OF A GENERAL MUNICIPAL ELECTION TO BE HELD ON TUESDAY, NOVEMBER 5, 2024 FOR THE ELECTION OF CERTAIN OFFICERS AS REQUIRED BY THE PROVISIONS OF THE LAWS OF THE STATE OF CALIFORNIA RELATING TO GENERAL LAW CITIES

WHEREAS, under the provisions of the laws relating to general law cities in the State of California, a General Municipal Election shall be held on November 5, 2024, for the election of three Members of the City Council for four-year terms; and

# NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF NORWALK HEREBY DETERMINES, FINDS, AND RESOLVES AS FOLLOWS:

- <u>Section 1</u>. Pursuant to the requirements of the laws of the State of California relating to General Law Cities, there is called and ordered to be held in the City of Norwalk California, on Tuesday, November 5, 2024, a General Municipal Election for the purpose of electing three Members of City Council for the full term of four years.
- **Section 2.** The ballots to be used at the election shall be in form and content as required by law.
- <u>Section 3</u>. The City Clerk is authorized, instructed, and directed to coordinate with the County of Los Angeles Registrar-Recorder/County Clerk (Registrar) to procure and furnish any and all official ballots, notices, printed matter and all supplies, equipment and paraphernalia that may be necessary in order to properly and lawfully conduct the election.
- <u>Section 4</u>. The vote centers, operated by the Registrar's office, for the election shall be open as required during the identified voting period pursuant to Sections 4007 and 14401 of the Elections Code of the State of California.
- <u>Section 5</u>. In all particulars not recited in this resolution, the election shall be held and conducted as provided by law for holding municipal elections.
- <u>Section 6</u>. Notice of the time and place of holding the election is given and the City Clerk is authorized, instructed and directed to give further or additional notice of the election, in time, form and manner as required by law.
- <u>Section 7</u>. The City Clerk shall certify to the passage and adoption of this Resolution and enter it into the book of original Resolutions.
- <u>Section 8</u>. The City Council authorizes the City Clerk to administer said election and all reasonable and actual election expenses shall be paid by the City upon presentation of a properly submitted bill.

<u>Section 9</u>. The Mayor, or presiding officer, is hereby authorized to affix her signature to this Resolution signifying its adoption by the City Council of the City of Norwalk, and the City Clerk, or her duly appointed assistant, is directed to attest thereto.

#### **RESOLUTION NO. 24-31**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF NORWALK REQUESTING THE BOARD OF SUPERVISORS OF THE COUNTY OF LOS ANGELES TO CONSOLIDATE THE CITY OF NORWALK'S GENERAL MUNICIPAL ELECTION TO BE HELD ON NOVEMBER 5, 2024, WITH THE STATEWIDE GENERAL ELECTION TO BE HELD ON THE DATE PURSUANT TO §10403 OF THE ELECTIONS CODE

WHEREAS, the City Council of the City of Norwalk called a General Municipal Election to be held on November 5, 2024, for the purpose of electing three Members of the City Council for four-year terms; and

WHEREAS, the City is required to consolidate the General Municipal Election with the Statewide General Election to be held on the same date and that within the city the precincts, polling places (vote centers) and election officers of the two elections be the same, and that the county election department of the County of Los Angeles canvass the returns of the General Municipal Election and that the election be held in all respects as if there were only one election.

## NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF NORWALK HEREBY DETERMINES, FINDS, AND RESOLVES AS FOLLOWS:

- <u>Section 1</u>. Pursuant to the requirements of §10403 of the Elections Code, the Board of Supervisors of the County of Los Angeles is hereby requested to consent and agree to the consolidation of a General Municipal Election with the Statewide General Election on Tuesday, November 5, 2024, for the purpose of electing three Members of the City Council for four-year terms.
- <u>Section 2</u>. The county election department is authorized to canvass the returns of the General Municipal Election. The election shall be held in all respects as if there were only one election, and only one form of ballot shall be used. The election will be held and conducted in accordance with the provisions of law regulating the statewide or special election.
- <u>Section 3</u>. The Board of Supervisors is requested to issue instructions to the county election department to take any and all steps necessary for the holding of the consolidated election.
- <u>Section 4</u>. The City of Norwalk recognizes that additional costs will be incurred by the County by reason of this consolidation and agrees to reimburse the County for any costs.
- <u>Section 5</u>. The City Clerk is hereby directed to file a certified copy of this resolution with the Board of Supervisors and the county election department of the County of Los Angeles.

<u>Section 6</u>. The Mayor, or presiding officer, is hereby authorized to affix her signature to this Resolution signifying its adoption by the City Council of the City of Norwalk, and the City Clerk, or her duly appointed assistant, is directed to attest thereto.
