Oppose	Monisha Parker	<p>Dear Board of Supervisors,</p> <p>I am writing to express my deep frustration, along with the sentiments of many Los Angeles County residents, regarding your ongoing reports on the county's implementation of the initiatives aimed at assisting people experiencing homelessness. While I acknowledge the importance of addressing this critical issue, it has become abundantly clear that the current strategies are not effectively solving the homelessness crisis that we face in our communities.</p> <p>The situation has reached a breaking point. As residents, we are inundated with heart-wrenching stories and statistics, yet we see little change on the ground. The number of people living on the streets continues to rise, and it feels as though the measures being implemented do not translate into meaningful action. People are suffering, and it is disheartening to see our county unable to provide the necessary support and resources that would foster real solutions.</p> <p>Now, amid this backdrop, you are asking us to support Measure A, which proposes an increase to the half-cent sales tax. While the intention behind enhancing funding for homelessness solutions may be well-meaning, I must express my deep concerns. The cost of living in Los Angeles County is already excessively burdensome for many families and individuals. We are faced with skyrocketing housing prices, rising rents, and the ever-increasing price of everyday necessities. The idea of implementing a new tax, particularly when residents are struggling to make ends meet, feels out of touch with the current realities of our lives.</p> <p>We need actionable change, not just reports and proposals for further taxation. We need concrete plans that will allocate resources effectively to provide immediate and sustainable solutions for those experiencing homelessness. It is imperative that we engage with community members, service providers, and advocates to develop an approach that is both compassionate and effective.</p> <p>In closing, I urge you to reconsider your path forward. We need transparency, accountability, and a genuine commitment to solving the homelessness crisis that plagues our beautiful county. It is time for the Board to put aside half-measures and abstract reports and instead take decisive action that addresses the root causes of homelessness.</p> <p>Thank you for your attention to this urgent matter.
