**RESOLUTION OF THE BOARD OF DIRECTORS OF  
CENTRAL BASIN MUNICIPAL WATER DISTRICT  
REQUESTING THE BOARD OF SUPERVISORS OF THE COUNTY OF LOS  
ANGELES TO PERMIT THE REGISTRAR-RECORDER/COUNTY CLERK  
TO RENDER ELECTION SERVICES FOR AN ELECTION TO BE HELD ON  
NOVEMBER 5, 2024**

**BE IT RESOLVED BY THE BOARD OF DIRECTORS OF CENTRAL BASIN  
MUNICIPAL WATER DISTRICT as follows:**

**WHEREAS**, the California Election Code permits special districts electing governing board members to call an election:

**WHEREAS**, an election in the Central Basin Municipal Water District is to be held on Tuesday, November 5, 2024, for the purpose of electing one member to the Board of Directors of said Divisions 1, 2 and 4;

**WHEREAS**, the Board of Directors believes that it is desirable that said election be conducted with the General District Elections to be held on the same date and that within said division the precincts, polling places and election officers of the election be made, and that the Registrar-Recorder/County Clerk of the County of Los Angeles canvass the returns of the election and that said divisions 1, 2 and 4, election, be held in all respects as if there were only one election;

**NOW, THEREFORE, THE BOARD OF DIRECTORS OF CENTRAL BASIN  
MUNICIPAL WATER DISTRICT HEREBY RESOLVES, DETERMINES, AND ORDERS  
AS FOLLOWS:**

1. That an election is hereby called by the Board of Directors of the **Central Basin Municipal Water** District to be held on November 5, 2024 for the purpose of electing one member of the Board of Directors.

2. That pursuant to the requirements of Section 10403 of the Elections Code, the Board of Supervisors of the County of Los Angeles is hereby requested to consent and agree to conduct the divisions 1, 2 and 4 election with the Tuesday, November 5, 2024, Statewide General Election for the purpose of electing members to the Board of Directors of said district.

3. Said Registrar-Recorder/County Clerk is hereby authorized to canvass the returns of the divisions 1, 2 and 4 election.

4. Said Board of Supervisors is hereby requested to issue instructions to the Registrar-Recorder/County Clerk to take any and all steps necessary for the holding of said election.

5. **Central Basin Municipal Water District** shall pay in full its pro rata share of the expenses for the conduct of the election.

6. **Central Basin Municipal Water District** shall require each candidate to pay in advance his or her pro rata share of the printing, handling and mailing costs of his/her candidate statement as a condition to having it included in the voter's sample ballot pamphlet.


7. The word limit for candidate's statements shall be 200 words.

8. The Secretary shall file a certified copy of this resolution with the Board of Supervisors and the Registrar-Recorder/County Clerk of the County of Los Angeles.
