			Edward de la Torre	<p>I am writing on behalf of The California Endowment in support of the Exclusive Negotiating Agreement (ENA) with Linc Housing Corporation (Linc Housing) for the New High Village Development Project. This project will bring much needed permanent affordable housing as well as retail and community-serving uses to the Chinatown community. I urge you to vote in favor of executing the ENA so this project can move forward.</p> <p>Linc Housing has been a development partner with The California Endowment on a project which is walking distance from the New High Village project site. The Robert K. Ross Center for Hope and Healing (Ross Center) aims to tackle the urgent issues of the lack of affordable housing and limited access to essential services in our community. Beyond providing housing, the Ross Center envisions a holistic approach to community development with an approximately 66,000 square foot community care component. Linc Housing has been a wonderful partner committed to community ownership and visioning, excellence in design, and creativity and transparency to move our project forward.</p> <p>The Ross Center, in conjunction with proposed projects like New High Village, Homeboy Industries expansion, William Mead Homes Transformation Plan, and the completed Care First Village, look to transform this area into Hope Village by re-imagining a multi square mile geographic area into a place for hope and healing that centers racial justice and provides affordable housing and full-scale community services to uplift the economic and societal well-being of underserved communities.</p>
