I am Ricardo Hernandez, CEO of Estamos Contigo-Safe Harbor or EC-SH. I will be speaking on Items 1-D, 89 and 88, and public comment.

As a former Senior Financial Loan Officer of 20 years, for Bank of America, Countrywide and Wells Fargo, I realized that the county has no known sector, that does research and development needed for debt reduction.
