Dear Honorable Board of Supervisors,

As Secretary of the Board for the Los Angeles County Library Foundation, I am writing on behalf of myself and the undersigned board members and executive director to express our strong support for the motion titled “Enabling County Libraries to Better Serve Their Unhoused Patrons.” Los Angeles County Public Libraries are not just repositories of books—they are vital community hubs that serve as pathways to imagination, citizenship, and greater engagement with our diverse county. Our libraries have earned national recognition for their innovative programs and commitment to inclusivity, and they continue to be a source of pride and inspiration for the communities they serve.

However, we must acknowledge the reality that many community members who are in dire need of help also rely on our libraries. This motion not only seeks to address immediate needs but also sets a model for how other communities can thoughtfully and effectively respond to similar challenges.

We urge the Board of Supervisors to approve this motion and demonstrate that Los Angeles County is committed to addressing the complex needs of all its residents with both brilliance and compassion.


