12.		Other	Sandie Parra	The community in unincorporated areas has been advocating for years on illegal drugs and shops, causing suicide ideation, mental illness, and drug addiction. The LA County Board of Supervisors, LA county administrative offices and counsel silence The board needs to issue an executive order based banning now and swift action on The 2018 Farm Bill defined hemp as "a marijuana plant with .3% THC or less BY WEIGHT." "By weight" creates one of the loop holes. It allows for finished products to contain significant amounts of THC. Here's the math ".3% THC by weight" means 1 tsp of hemp extract can contain up to 13.65mg of THC or 1 TB of hemp extract can contain up to 40.95mg of THC. Snack products for example can easily contain many many tablespoons of hemp - meaning that number x 40.95mg equals the amount of THC that can be in a finished product and still meet legal regulations. Then the chemistry problem. Laura explained well the isomerization of CBD - at the molecular level just a few bonds can be modified in a lab to create various types of THC that are intoxicating. Also, CBD and Delta9-THC are not the only cannabinoids found in cannabis/marijuana plants. Estimates of other cannabinoids range from 40-100. These can be extracted directly from the hemp plant - a lab and isomerization is not required. Because the 2018 Farm Bill is silent on all cannabinoids other than Delta9-THC and CBD, the Industry has assumed others are allowed. Hence the explosion of intoxicating hemp-based compounds and products. Many states and counties banned and allowed only hemp products - just in Los Angeles, CA the LA county offices and LA County Board have allowed the explosion of illegal drugs and high concentration THC causing suicides and mental issues.
