Honorable Members of the Board:

Re: Violations of Board Directives and Priorities

First District Supervisor Hilda L. Solis, in collusion with Department of Parks and Recreation Director Norma Edith Garcia have been systematically harassing the *Ranchera Culture* of the greater Hispanic Culture for the entire length of her term by systematically reducing the availability and functionality of the equestrian facilities at Whittier Narrows equestrian arena, Avocado Heights Park equestrian arena and the interconnecting County Trails throughout the local and greater County areas. The intent of Supervisor Solis and Director Garcia is clearly focused on driving the equestrians out of Los Angeles County so their large properties can be acquired for high density housing for low income tenants.

The harassment of this cultural group and the multiple racial groups within it is clearly a violation of the Board's Anti-Racism, Diversity and Inclusion (ARDI) Initiative and must be reversed immediately!

It is entirely appropriate to bring this issue to the entire Board during L.A. County's Hispanic Heritage Month. As this issue directly involves the First District Supervisor, Hilda L. Solis, the Board must deal with this issue as a whole. The status quo of allowing a District Supervisor to self-deal regarding issues within their District is simply not available when violation of multiple Board Directives are involved.

As I am the County resident who has officially lodged this complaint, I expect to be contacted immediately by that staff person in the office of the Board Chair with the specific details of which County Department the issues have been forwarded to – no later than September 18 midday. No later than September 19 midday I expect to be contacted by that person in the Department assigned to investigate the violation. When I am contacted by said office's assigned person, I expect to be given a clear outline of the investigative protocol which will be followed and the time line to expect a follow up contact.

Thank you for your very critical attention to this very serious issue.
