RESOLUTION NO. 24-57

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MONTEBELLO, CALIFORNIA, ACCEPTING THE CERTIFICATE OF SUFFICIENCY OF SIGNATURES ON THE PETITION TO RECALL COUNCILMEMBER ANGIE JIMENEZ

RECITALS

WHEREAS, on April 29, 2024, the City Clerk/Elections Official received a copy of the Notice of Intention to Circulate Recall Petition, which proposed the recall of Council Member Angie Jimenez; and

WHEREAS, on May 27, 2024, the Petition for Recall form was determined to meet the statutory requirements and thus approved for signature gathering; and

WHEREAS, Elections Code Section 11220 provides that the number of required signatures must be equal to not less than twenty-five (25%) of Montebello registered voters; and

WHEREAS, according to the Report of Registration filed with the Secretary of State, Montebello has 5,553 registered voters, and thus 1,388 verified signatures were required for this Petition; and

WHEREAS, on July 2, 2024, the Petition to Recall Council Member Angie Jimenez was filed with the City Clerk's Office in accordance with Elections Code Section 11220, prior to the established deadline of August 21, 2024; and

WHEREAS, after completing the prima facie review of signatures, the City Clerk/Elections Official identified 2,704 unverified signatures, which is greater than the minimum 1,388 required, and provided the petition to the Los Angeles County Clerk-Recorder and Elections Department for examination and verification of the signatures on July 2, 2024; and

WHEREAS, on July 18, 2024, the Los Angeles County Clerk-Recorder and Elections Department provided information for the Certificate of Sufficiency of the Recall Petition, indicating the following, and attached hereto:

- (a) The name of the Officer whose recall is sought – Angie Jimenez
- (b) The title of his or her office – Council Member of District 5
- (c) The number of signatures required by law – 1,388
- (d) The total number of signatures on the petition – 2,700
- (e) The number of valid signatures on the petition – 2,023
- (f) The number of signatures which were disqualified - 677



A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MONTEBELLO, CALIFORNIA, REQUESTING THE BOARD OF SUPERVISORS OF THE COUNTY OF LOS ANGELES TO CONSOLIDATE A RECALL ELECTION WITH THE GENERAL ELECTION TO BE HELD ON NOVEMBER 5, 2024

RECITALS

WHEREAS, the City of Montebello, California, has received a valid petition for the recall of certain elected officials; and

WHEREAS, the City Council of the City of Montebello desires to submit the question of the recall of the officials named in the petition to the voters; and

WHEREAS, it is in the best interest of the City of Montebello to consolidate the recall election with the general election to be held on November 5, 2024, to ensure a cost-effective and efficient election process; and

WHEREAS, Section 10403 of the California Elections Code authorizes the City Council to request the Board of Supervisors of the County of Los Angeles to consolidate the recall election with the general election.

NOW THEREFORE, THE CITY COUNCIL OF THE CITY OF MONTEBELLO DOES RESOLVE, DECLARE, DETERMINE, AND ORDER AS FOLLOWS:


