I. WELCOME AND INTRODUCTION

1. Call to Order and Roll Call. (24-3739)

Chair Plascencia called the meeting to order at 9:40 a.m. Ivonne Umana, administrative staff, called the roll.

A quorum was established with nine (9) members present.

Commissioner Schockman left the meeting at 11:59 a.m. and Commissioner Vasquez left the meeting at 12:14 p.m.

2. Land Acknowledgment and a "Moment of Silence." (24-3948)

Sunitha Menon, Executive Director, read the Los Angeles County Land Acknowledgment.

Chair Plascencia led the "Moment of Silence" inviting everyone to take three breaths for past, future and present trans and queer LGBTQ+ given and chosen lineage.

II. ADMINISTRATIVE MATTER

3. Approval of the August 20, 2024, regular meeting minutes. (24-3740)

Member of the public Joseph Farragher addressed the Commission on this item.

On motion of Second Vice Chair Russell-Slavin, seconded by Commissioner Martinez, and duly carried, the August 20, 2024, regular meeting minutes were approved by the following vote:

III. DISCUSSIONS AND ACTIONS

4. Report back on membership of subcommittee and activities; and, discuss and take appropriate action on the sticker design, voting one-pager, and video script. (24-3744)

Commissioner Martinez provided a brief report on the subcommittee and activities in relation to the October LGBTQ+ education campaign to encourage LGBTQ+ community to register to vote and the importance of participating in elections, with the goal to have information and materials available in advance of the November 5, 2024, election.

Commissioner Martinez opened the floor to the Commissioners on the flyer "Why Should LGBTQ People Vote in California" for comments and suggestions. In review of the flyer, the Commission made suggestions to grammar, adding "+" after LGBTQ on the title, and a question mark (?) at the end of the title.

Member of the public Joseph Farragher addressed the Commission on this item.

On motion of Commissioner Martinez, seconded by Vice Chair Rogers, and duly carried, the Commission approved the "Why Should LGBTQ People Vote in California" flyer, with the corrections in grammar, add "+" after LGBTQ on title, and add a question mark (?) at the end of the title:

Commissioner Martinez proceeded to introduce the next educational campaign with the viewing of the English and Spanish videos; and thereafter, opened the floor to the Commission for comments and suggestions.

Commissioner Vasquez noted and suggested that edits be made to the body language of the Spanish video. Commissioner Arnzen recommended that the speaker on the Spanish video include their name, title, and pronouns to be consistent with the English video.

Members of the public Alma Leyva and Byron José addressed the Commission on this item.

On motion of Commissioner Arnzen, seconded by Commissioner Vasquez, and duly carried, the Commission approved the Spanish video, and requested that the edits be made to body language and have the speaker include name, title, and pronouns to be consistent with the English video:

Discussion ensued about the artwork and the dissemination of materials. Sunitha Menon, Executive Director, informed that due to time constraints, the artwork was presented as is, but has taken notes for improvement in preparation for the next election. She also informed that there is collaboration with various County departments for the distribution of "I will Vote" stickers, including the flyer.

Member of the public Byron José addressed the Commission on this item.

By common consent (Commissioners Fisher, Reece and Soria being absent), the Commission accepted the verbal report presented by Second Vice Chair Russell-Slavin.

- Schedule Town Hall meetings
- Select specific topics that are geared geographically
- Have a booth during events
- Utilizing virtual platforms
- Prison reentry population
- University Resource Centers
- Parents of the Community
- Engage youth and relay that it is a safe zone

Commissioner Arnzen made a motion to establish a standing committee for the sole purpose to engage with the local LGBTQ+ Community. Commissioners Martinez and Abraham, and Vice Chair Rogers voiced interest in partaking in the standing committee.

Member of the public Byron José addressed the Commission on this item.

On motion of Commissioner Arnzen, seconded by Commissioner Khan-Valbuena, and duly carried, the Commission approved creation of a Standing Committee on LGBTQ+ Community Engagement:
