Taiwanese imports into the Los Angeles Customs District, which includes the Ports of Los Angeles and Long Beach, were valued at approximately \$9.5 billion, while exports to Taiwan reached \$7.6 billion. Electronics, metals, and aircraft equipment dominate the trade, with Taiwanese goods, especially electronics, playing a major role. Additionally, Taiwanese businesses have a significant presence in Los Angeles County, with over 164 Taiwanese-owned establishments contributing over 10,000 jobs and an estimated \$500 million in wages according to slideshare.net.

Re: Motion (24-4509) on the agenda of regular meeting of the Board of Supervisors to be held on October 8, 2024

The Consulate General of the People's Republic of China in Los Angeles presents its compliments to the Executive Office of the Board of Supervisors of Los Angeles County and lodges its serious concern regarding a motion so-called *Proclaiming October 10, 2024 as National Day of the Republic of China (Taiwan)* (24-4509) to be discussed on October 8. The Consulate General hereby requests the latter to take prompt action to avoid such a move which is detrimental to the friendly relations and cooperation between China and Los Angeles County.

The Consulate General would like to draw the attention of the Board of Supervisors on the following:

There is but one China in the world, Taiwan is an inalienable part of China's territory. On October 1, 1949, the People's Republic of China (PRC) was founded, becoming the successor to the Republic of China (1912-1949). The Government of the People's Republic of China is the sole legal government representing the whole of China. Taiwan region has never been a state, its status as part of China is unalterable. This is a universal consensus of the international community.

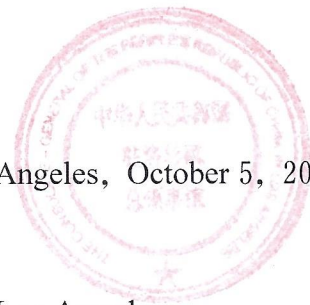
The one-China principle constitutes the political foundation for China-US relations. This principle is at the heart of the three China-US Joint Communiqués, whereas the US “recognizes the Government of the People’s Republic of China as the sole legal Government of China” and “acknowledges the Chinese position that there is but one China and Taiwan is part of China”.

The Taiwan question concerns China’s sovereignty, which is the core of the core interests of China, the bedrock of the political foundation of China-US relations, and the first red line that must not be crossed in China-US relations. There is no gray zone or room for ambiguity on the Taiwan question. China has consistently and firmly opposed any attempt to create the so called “two Chinas” or “one China, one Taiwan”.

The Chinese side attaches great importance to the development of relations with Los Angeles County, including economic and trade ties, people-to-people exchanges, and education and technological cooperation. It’s undeniable that Los Angeles County is a beneficiary of the mutual beneficial relations and cooperations between China and the U.S. To that end, it is critical for the Board of Supervisors of Los Angeles County to fully recognize the history and sensitivity of the Taiwan question, strictly adhere to the one-China principle, and avoid any move that may undermine the foundation of our relations. Board of Supervisors is therefore kindly requested to remove or nullify the above mentioned motion.

The Consulate General of the People’s Republic of China in Los Angeles avails itself of this opportunity to renew to the Los Angeles County Board of Supervisor of its highest consideration.
