Please close the loophole that allows a property owner's consent to excuse his own and a hauler's liability for illegal dumping.

Please ensure that the County creates stronger deterrents against illegal dumping through adoption and expansion of local ordinances and by supporting new state laws.

I fully support Kathryn Barger's request:

"That the Board of Supervisors direct County Counsel, in coordination with the Los Angeles County Fire Department, Department of Public Health, Department of Public Works, and the Department of Regional Planning to develop local ordinances to regulate land application of mulch and other compostable material to include local permitting requirements including, but not limited to:

1. Requirements for appropriate zoning, maximum duration of storage prior to land application, maximum height of storage piles, frequency and depth of application, and specific requirements for heavy metal concentration, physical contamination (non-organic material), and pathogen density;
2. Requirements of property owners to include in their agreement with mulch suppliers a provision that would require the supplier to be responsible for taking back any load that does not meet the land application requirements, such as physical contamination, heavy metal concentration, and pathogen density;
3. Requirements for property owners or mulch applicators to maintain a Fire Plan that would include measures to prevent spontaneous combustion, such as routine temperature checks of stockpiled mulch and minimum spacing requirements between mulch stockpiles;
4. Amendments to the Los Angeles County Fire Code to:
 - a. Increase fines in the code to provide greater flexibility in enforcement of illegal dumping violations and to recover cleanup costs related to illegal dumping and illegal land application activities;
 - b. Develop a "Contaminated Mulch Ordinance" to prohibit any construction and debris or any other non-organic material to be mixed with mulch and deposited on land; and
 - c. Expand the existing Fire Code Section 326.15 (Illegal Dumping in Hazardous Wildfire Areas) to include new subsections:
 - i. Section 326.15.1 (Mulch Permit) to require a permit for mulch piles greater than 12 inches in height, including fire prevention requirements and stipulations for fire suppression cost responsibilities; and
 - ii. Section 326.15.2 (Unpermitted Mulch Fires) to hold property owners financially responsible for fire suppression costs if a fire occurs on a parcel without a mulch permit, with pile depths greater than 12 inches."

I also support Kathryn Barger's request that, "the Board of Supervisors request the Los Angeles County Sheriff's Department to report back in writing in 21 days with a proposed procurement and deployment plan for technological solutions, including but not limited to, mobile cameras and license plate readers, to concentrate enforcement resources on known hot spots for illegal dumping and improper land application of mulch and other

Re: Public Comment to the Los Angeles County Board of Supervisors

My name is Daniel Vigil Rodriguez, and I am a resident of District 1, a member of the Re-Imagine LA Coalition, and the Senior Manager at The Social Impact Center.

As a Queer Mexican American community organizer from Southeast LA, my deep appreciation for my community is rooted in my own lived experiences. I grew up in a system-impacted, divorced household filled with stigma, and I often felt that this was the norm for many like me. My parents struggled with a sense of hopelessness about the future, and I have witnessed the challenges that come with accepting change—especially for those who are marginalized and stigmatized.

I hear these stories echoed repeatedly from community members whom we have helped. As a current grant awardee, I urge you to commit to crucial Care First Community Investment (CFCI) funding. With increased investment, the future looks brighter for our system-impacted communities. **It is time to stop investing in systems that perpetuate trauma and instead focus on compassionate care.** We need to close the jails and relocate this funding to more Care First Initiatives.

I urge you to think of the impact of expanded programs on our most vulnerable populations.

Thanks to CFCI funding, we've seen significant improvements in housing stability, mental health support, and employment services for those most affected by systemic inequities. However, the need far exceeds our current capacity. Without further investment, we risk losing the momentum we've built.

Currently, \$57.7 million has yet to be allocated to CFCI.

To truly build an equitable system, the county must ensure that funding for these essential services is increased and sustained. Short-term funding cannot provide the long-term stability that our communities need to thrive and break cycles of harm.

We demand greater transparency and accountability in the county's budget management. It is time to stop allowing litigation and settlements to consume the budget and instead redirect those funds toward sustainable investments in community-based solutions. Every unspent dollar and every settlement paid out represents a missed opportunity to strengthen the social safety net. We cannot afford to waste these resources while so many residents struggle to access wrap-around services, housing, healthcare, and other critical services.
