Honoring Loved Ones at Gloria Molina Grand Park’s 13th Annual Downtown Día de los Muertos

Día de los Muertos, or the Day of the Dead, is a time-honored celebration that honors the lives and memories of those who have passed away, deeply rooted in Indigenous Mexican traditions, and enriched by Catholic influences. This revered tradition is characterized by its vibrant and respectful customs, including the creation of intricate altars (*ofrendas*), the offering of traditional foods, the adornment of graves with marigolds and candles, and the performance of music and dance.

Gloria Molina Grand Park has emerged as a central cultural venue in our community, providing a prominent and accessible space where individuals from all backgrounds can come together to participate in and celebrate Día de los Muertos, reflecting the diverse cultural tapestry of Los Angeles County. The Día de los Muertos celebrations at Gloria Molina Grand Park have grown significantly in scale and impact, evolving into a cornerstone program that not only honors and celebrates cultural

3. Direct the Los Angeles County Chief Executive Office to work with The Music Center in encouraging Los Angeles County departments to participate in upcoming Gloria Molina Grand Park Annual Downtown Día de los Muertos celebrations so that they can feature an altar or provide programming support.
