			MARK H CLAYSON	I suggest suspending the development plans for 220 residential units in a 6-story building on the corner of Marine and Crenshaw in El Camino Village (unincorporated LA County). I suggest if not a cancellation (which most residents at the town hall voiced agreement with, despite lawsuit penalties), at least a reduction in size to no more than 3 stories, or about half the units. Multiple such 3-story developments could replace both this site as well as the proposed 15335 Crenshaw 7-story development only ¼ mile away, with less impact on the community (more in character with the maximum of 3 stories in the area) if more spread out in multiple locations.	
				In my 38 years living in Gardena less than ½ mile from the corner of Marine & Crenshaw, I've seen massive development of high density housing (many hundreds of units) along the Rosecrans corridor near Crenshaw, and on Marine, apartment buildings along Crenshaw, etc. (see below for a partial list – much of it in the last 5 years). I.e., there is plenty already, and in that time there have been no increases in infrastructure like parks or roads to accommodate the additional people and much worse traffic. Thornburg Park on Daphne Ave. where I live is the nearest park to the proposed site, and most likely to be used by people there – it is already much-used by people coming from over ½ mile away, and more so now with Marine Place.	
				Also, note that none of those within $\frac{1}{2}$ mile are more than 3 stories 6 or 7 stories are totally out of character with our area.	
				Many have expressed concerns over parking, property values, traffic congestion, quality of life issues, etc. And asked why outlying areas with more open spaces for development, parks, etc. aren't preferable.

I am not against affordable housing, and feel that there is a need, but a 1,200% density bonus seems excessive without having to consider the impact on the existing community.
