				The Social Justice Learning Institute is writing in support of Item 17 because the County's policymaking process needs to be more transparent and accountable.
				Decision-making within Los Angeles County can be complex, yet it often moves quickly and without ample time for the public and key stakeholders to review and provide thoughtful feedback on important legislative proposals.
				Today, motions are placed on a public agenda only three business days before a Tuesday Board meeting, and the public is often not aware of the proposal until it has already become law. The Board's current process disenfranchises individuals who do not have the time or agency to analyze Board agendas in less than three business days and prepare written or verbal public comments. Moreover, the truncated policymaking process also does not provide meaningful time for Board members and their staff time to have robust discussion about proposals with the public and affected County departments. Establishing a structure within the County to vet policy proposals before they reach the Board for a vote is not just beneficial but crucial for effective governance and for sharing power with the community. This motion would allow Supervisors and staff to leverage expertise from departments, collect stakeholder feedback, weigh perspective from the public, and ensure that all policy proposals are scrutinized for feasibility, impact, and alignment with County priorities, by leveraging existing cluster meeting structure. We know when policy includes more thoughtful deliberation and time for stakeholder feedback, it is more responsive in addressing community
				needs. We believe this is an important step forward to making our County government more accountable and transparent to all Angelenos. This along with the study effort for additional governance reforms are exactly what we
				need to do. Having ways to get community involvement and engagement should always be strategy utilized.
				For these reasons, the Social Justice Learning Institute respectfully asks for your "Aye" vote.

Item 17: Support - Encouraging Public Participation and Deliberation

Dear Honorable Board of Supervisors,

On behalf of the California Apartment Association, I am writing to express our strong support for the motion introduced by Supervisors Mitchell and Barger, which requires board motions to first be introduced in a policy cluster before being placed on the full board agenda. As a trade organization representing housing providers and related stakeholders, we believe this motion is a vital step toward promoting greater transparency, inclusivity, and accountability in Los Angeles County's governance.

The current process, where motions can be introduced with limited time for public scrutiny or feedback, restricts the ability of those most impacted by policy decisions to participate meaningfully. By vetting motions through policy clusters, this proposal creates a more structured and deliberate approach that ensures all voices can be heard and contribute to the development of effective policies.

Furthermore, engaging the public early in the process will improve the quality of the Board's decisions.
