**Los Angeles County Holiday Events at The Music Center 2024 Parking Waiver**

For decades, the County of Los Angeles (County) has hosted the Annual Tree Lighting Ceremony and the Annual Holiday Celebration at The Music Center in Downtown Los Angeles.

The Tree Lighting Ceremony will be held on December 2, 2024, at 5 p.m. at Jerry Moss Plaza at The Music Center and provides the Los Angeles public and County employees with a festive welcome to the holiday season. This ceremony will include live holiday performances by a local performing arts group, free hot chocolate and cookies, as well as an art activity for all ages facilitated by local artists. The event will be hosted by a newscaster and be featured by local media.

The Holiday Celebration will be held on December 24, 2024, at 3 p.m. in the Dorothy Chandler Pavilion. The event, in its 65th year, will reach thousands of live audience members and tens of thousands of at-home viewers. The Holiday Celebration performers represent music, dance, circus, puppetry, and choral companies from across the County and, in preparation for the show, the performers and crew members are required to attend several rehearsals at The Music Center.

As in the past, parking waivers are requested for both events including the mandatory Holiday Celebration rehearsals.

**I, THEREFORE, MOVE THAT THE BOARD OF SUPERVISORS:**

1. Waive the following parking fees for the dates listed below in Lot 14 (The Music Center Garage), excluding the cost of liability insurance, to accommodate artists, crew and VIPs performing and participating in the Annual Tree Lighting Ceremony on Monday, December 2, 2024, from 12:00 p.m. to 8 p.m.:
  - a. Waive the \$10 per vehicle parking fee for 12 vehicles for a total of \$120, on December 1, 2024;
  - b. Waive the \$20 per vehicle parking fee for 20 vehicles for a total of \$400, on December 2, 2024, and;
2. Waive the following parking fees for the dates listed below in Lot 14 (The Music Center Garage), and Lot 16, if necessary, excluding the cost of liability insurance, for the 65<sup>th</sup> Annual Los Angeles County Holiday Celebration in the Dorothy Chandler Pavilion:
  - a. Waive the \$10 per vehicle parking fee for up to 600 vehicles for a total of \$6,000, on December 7-8, 2024;
  - b. Waive the \$20 per vehicle parking fee for 50 vehicles per day for a total of \$1,000, on December 17, 2024;
  - c. Waive the \$20 per vehicle parking fee for 100 vehicles per day for a total of \$2,000, on December 19, 2024;
  - d. Waive the \$20 per vehicle parking fee for 100 vehicles per day for a total of \$2,000, on December 20, 2024;
  - e. Waive the \$10 per vehicle parking fee for 200 vehicles per day for a total of \$4,000, on December 21-22, 2024;
  - f. Waive the \$20 per vehicle parking fee for 200 vehicles per day for a total of \$4,000, on December 23, 2024;
  - g. Waive the parking fees, excluding the cost of liability insurance, \$20 per vehicle for the entire Lot 14 (The Music Center Garage) and the entire Lot 16 if necessary, and 20 ADA valet at the main valet (AP14)

for all members of the public visiting The Music Center for a total of \$50,000, on December 24, 2024.

- h. Waive the \$20 per vehicle parking fee for 50 vehicles per day for a total of \$1,000, on December 27, 2024;
- i. Waive the \$10 per vehicle parking fee for 12 vehicles per day for a total of \$240, on December 28-29, 2024; and
- j. Waive the \$20 per vehicle parking fee for 12 vehicles per day for a total of \$240, on December 30, 2024.
