A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF REDONDO BEACH, CALIFORNIA, CALLING AND GIVING NOTICE OF THE HOLDING OF AN ALL-MAILED BALLOT GENERAL MUNICIPAL ELECTION CONSOLIDATED WITH THE ELECTION OF THE BOARD OF EDUCATION OF THE REDONDO BEACH UNIFIED SCHOOL DISTRICT, TO BE HELD IN SAID CITY ON TUESDAY, MARCH 4, 2025, FOR THE ELECTION OF CERTAIN OFFICERS OF THE CITY AND MEMBERS OF THE BOARD OF EDUCATION OF SAID SCHOOL DISTRICT, AS REQUIRED BY THE PROVISIONS OF THE CHARTER OF THE CITY OF REDONDO BEACH

WHEREAS, under the provisions of the Charter of the City of Redondo Beach, California, a General Municipal Election consolidated with the election of the Board of Education of the Redondo Beach Unified School District, shall be held on Tuesday, March 4, 2025, for the election of certain officers of the City of Redondo Beach and for Members of the Board of Education of the School District of the City; and

WHEREAS, the election is called for the purpose of electing a Mayor, Members of the City Council from Districts 1, 2, and 4, a City Attorney, and three Members of the Board of Education for full terms of four years.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF REDONDO BEACH, CALIFORNIA, DOES HEREBY RESOLVE AS FOLLOWS:

SECTION 1. That pursuant to the requirements of the Charter of the City of Redondo Beach, there shall be, and there is hereby called and ordered held in the City on Tuesday, March 4, 2025, a General Municipal Election by All-Mailed Ballot for the purpose of electing:

- A Mayor for the FULL term of four (4) years;
- A member of the City Council representing District 1 for the FULL term of four (4) years;
- A member of the City Council representing District 2 for the FULL term of four (4) years;
- A member of the City Council representing District 4 for the FULL term of four (4) years
- A City Attorney for the FULL term of four (4) years; and
- Three members of the Board of Education of the Redondo Beach Unified School District for the FULL term of four (4) years.

SECTION 2. That the ballots to be used at the election shall be in the form and content as required by law.

SECTION 3. That the City Clerk is authorized, instructed, and directed to procure and furnish any and all official ballots, notices, printed material and all supplies equipment, and paraphernalia that may be necessary in order to properly and lawfully conduct the election.

SECTION 4. That pursuant to the State Elections Code, the City of Redondo Beach Municipal Code, and other applicable provisions of the City Charter and Ordinances of the City of Redondo Beach, said Election shall be conducted by All-Mailed Ballot, and shall be conducted pursuant to Chapter 2, Division 4 (commencing with Section 4100 of the California Elections Code), notwithstanding the limitations of California Elections Code, Section 4000 et seq., only insofar as required by law. Ballots cast in this General Municipal Election shall be returned to the official drop off locations no later than 8:00 p.m., on Election Day. Pursuant to the Election Code Section 3020, Vote-by-Mail ballots received via United States Postal Service or a bona fide private mail delivery company must be postmarked or date/time stamped by March 4, 2025, and received by the elections official no later than 7 days after election day.

SECTION 5. That on March 7, 2023, the voters of the City of Redondo Beach adopted Measure CA5, an amendment to the City Charter of the City of Redondo Beach, replacing runoff elections for elections for Municipal Elective Offices of the City with Ranked Choice Voting, also known as Instant Runoff Voting.

SECTION 6. That in all particulars not recited in this Resolution, the election shall be held and conducted as provided by law for holding municipal elections.

SECTION 7. That notice of the time and place of holding the election is hereby given and the City Clerk is hereby authorized, instructed, and directed to give further or additional notice of the election in time, form, and manner as required by law.

SECTION 8. That in the event of a tie vote as determined by the Elections Official, the Elections Official will refer to the Redondo Beach Municipal Code Section 2-2.405, or the City Council adopted Resolution No. CC-2410-089, whichever applies.

SECTION 9. That the City Clerk shall certify to the passage and adoption of this Resolution and shall enter the same in the Book of Original Resolutions.

SECTION 10. The City Council authorizes the City Clerk to administer said election and all reasonable and actual election expenses shall be paid by the City upon presentation of a properly submitted bill.

RESOLUTION NO. CC-2410-091**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF REDONDO BEACH, CALIFORNIA, REQUESTING THE BOARD OF SUPERVISORS OF THE COUNTY OF LOS ANGELES TO RENDER SPECIFIED SERVICES TO THE CITY RELATING TO CONDUCTING AN ALL-MAILED BALLOT GENERAL MUNICIPAL ELECTION CONSOLIDATED WITH THE ELECTION OF MEMBERS TO THE BOARD OF EDUCATION OF THE REDONDO BEACH UNIFIED SCHOOL DISTRICT TO BE HELD ON TUESDAY, MARCH 4, 2025**

WHEREAS, a General Municipal Election is to be held in the City of Redondo Beach, California, on March 4, 2025 consolidated with the Election of Members to the Board of Education of the Redondo Beach Unified School District; and

WHEREAS, in the course of conduct of the election it is necessary for the City to request services of the County of Los Angeles; and

WHEREAS, all necessary expenses in performing these services shall be paid by the City of Redondo Beach; and

WHEREAS, the City of Redondo Beach is a Charter City; and

WHEREAS, the Municipal Code of the City of Redondo Beach Section 2-2.206 states that the City Council may, by resolution, provide for an election by mailed ballot notwithstanding the limitations of California Elections Code, Section 4000 *et seq.*

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF REDONDO BEACH, CALIFORNIA, DOES RESOLVE, DECLARE, DETERMINE AND ORDER AS FOLLOWS:

SECTION 1. That pursuant to the provisions of Section 10002 of the Elections Code of the State of California, the City Council requests the Board of Supervisors of the County of Los Angeles to permit the County Elections Department to prepare and furnish to the City and their authorized vendors for use in conducting the election, computer data consisting of the names and addresses and current precinct of all eligible registered voters in the City of Redondo Beach in order that the City may print labels for mailing and/ or by electronic mail the Voter Information/Sample Ballot pamphlet to all registered voters in the City and for processing vote by mail ballots; provide other services, which may include consolidation of precincts as directed by the City; and to make available to the City additional election equipment and assistance according to State law.


SECTION 2. That the City shall reimburse the County for services performed when the work is completed and upon presentation to the City of a properly approved bill.

SECTION 3. That the City Clerk is directed to forward without delay to the Board of Supervisors and to the County Election Department, each a certified copy of this resolution.

SECTION 4. That the Board of Supervisors is requested to issue instructions to the County Elections Department to take any and all steps necessary for the holding of the election.


SECTION 5. That the City Clerk shall certify to the passage and adoption of this Resolution and enter it into the Book of Original Resolutions.


