Now, I have been sent home to use my own time including partial time. I'm not even allowed to return to work because of work restrictions that I have suffered from work injuries. No reasonable accommodations where as beforehand, I was allowed to do my job and provide service to my clients. I was told by DMC unit, a disability retirement application is being sent on my behalf because of my permanent work restrictions due to my work injuries. To me, the message here I am useless to the department that at one time I loved to work for. I am embarrassed by the way this dictator of a chief has treated all of us. I am embarrassed of certain oversight commissioners who are majority in a conflict of interest because they are on organizations such as ARC and others similar to such. They are to be impartial and helpful but they continue to bash all Probation Officers and Detention Service Officers. These said groups perpetuate the exact biases and support the abusive methods the Chief has enacted against the Probation Officers in the field. Local 685 is useless; all they care about is saving their 56 hour shifts and travel at the expense of the membership. You hire so called experts from San Bernardino County and what happened? Things got worse. The Probation Department has been demolished. You lost veteran staff who would've helped if they were treated with dignity. The same treatment you as a human being would want.
