Please, allow to use rural land to live as residence without building and zoning draconian regulations. Just like the shelters exempted here. People are living at small huts 6 persons at room in the shelters made from concrete blocks, so I urge the County to allow the INDEPENDENT way of living. The County pays \$1700 for each bed at the shelters and it is more beneficial to allow the sacred right to live in OWN land without risk to be evicted from any construction on private land used for living.
			Fedor Simanov	We are discussing now how County is doing a good job of destroying Homeless Encampments and prohibiting to sleep at public places after that Mr Gorsuch Court Decision. I am surprised that out of the many thousands of affected people, I am the only one standing here and keeping my word. Because no alternative was provided, the County now prohibits sleeping on the street and prohibits sleeping on people's own property. I call this an atrocity and I call for it to be changed. People have been deprived of this sacred right by zoning and building regulations.  The latest audit showed that millions were stolen from shelter programs, people were living in terrible conditions.  Did you arrested somebody who stole that money and putted them in jail? No. But if I will use my land your departments will put me in jail or arrest my property or do both.  The shelters cannot resolve the problem of homelessness, but are exempted by the county from building and zoning rules.  What I proposing to you:  To establish a new form of land use: a Private Household Plot. It's a program to establishing a private homestead on the land own by a private owner only for owner's land use and with entry for landowner and other owners included in a title. Or to make it in form of a covenant between county and eligible person. For homeless, refugee or disabled use. Make this land in the rural areas exempted from building and zoning codes just like you exempted a homeless providers.  And this will relieve me, the disabled, the homeless and the refugees from the constant stress of dying on the street.
