15.		Favor	Diana Cruz	Animal shelters are at capacity. The housing crisis in LA County continues to grow. We need practical solutions to these issues and Item #15 is a step in that direction. An estimated 213,420 households in LA County and an estimated 305,190 pets are expected to be evicted in the next 30-90 days (humananimalsupportservices.org/toolkit/pet-eviction-calculator/). These numbers do not include tenants that are threatened with eviction due to their companion animals or assistance animals.
				Eviction filings have continued to increase since the emergency period ended. 47,365 evictions were filed last year- that's 5 families evicted every hour. These numbers do not include families that self-evict due landlord harassment and illegal eviction threats that force people to choose between the roof over their heads and their furry family members.
				I came to work at the organization I am with now, Housing Equity & Advocacy Resource Team (HEART) because I used to be a client. My family struggled finding pro bono representation for our no-fault eviction and finding affordable housing that would allow pets. We spent over \$300 in application fees alone but were ultimately rejected due to no-pet clauses despite the fact that my cat is an emotional support animal. HEART LA provided legal representation for us like it continues to do for families across LA County that are facing housing insecurity due to their companion animals.
				Unfortunately, my story is a common one. We are seeing an increasing number of unhoused individuals seeking resources for their animals and support finding inclusive housing. No-pet policies, pet fees, pet deposits, breed restrictions, and weight restrictions compound the problem and exist as barriers to entering and maintaining housing. Supervisor Solis and Supervisor

Honorable Members of the Board of Supervisors:

On behalf of the American Society for the Prevention of Cruelty to Animals (ASPCA), I am writing to express our support for Agenda Item 15, Keeping Pets and Families Together: Increasing Pet Equity in Housing (Motion). The Motion provides a productive first step for stakeholders to develop solutions that can ensure that renters aren't faced with a choice of keeping a roof over their head or surrendering their pet. We thank Supervisor Solis for her leadership in acknowledging the significant role that the County can take in avoiding this grim decision.

Founded in 1866, the ASPCA was the first humane society to be established in North America and is today one of the largest in the world. The ASPCA believes that pets and people belong together; that financial circumstances are not reliable indicators of the capacity to love and care for a companion animal, and that the strong bonds between people and pets make for healthier communities.

While we recognize the complex factors involved in the rental market, it is clear that the implications of restrictions on the keeping of pets in rental housing are many and highly detrimental to both pets and their people. The lack of supply of new housing has resulted in historically low vacancies and high rents in the rental market. While renters in general may have difficulty finding suitable housing options in the market, those households with pets are confronted with an even greater challenge. The tight rental market means landlords can be more discerning in the types of households they rent to and often exclude potential tenants with pets.

This is especially taxing for the ninety-seven percent of pet owners consider their pets part of their family. At a time of unprecedented housing instability for renters, the cost and availability of housing that allows pets is an increasing challenge for loving and responsible pet owners. As a result, thousands of dogs and cats are relinquished to County animal shelters every year, breaking apart families and adding additional stress to already difficult situations.

The ASPCA has been actively engaged in developing new pet-friendly housing laws at all levels of government, including the drafting of the pet-friendly affordable housing ordinances in both the City and County of Los Angeles. Through our work, we have gained a breadth of knowledge of the best practices for creating more equitable access to cost appropriate housing for families with pets. As such, we humbly offer our assistance with the stakeholder process.

Thank you for your humane leadership in promoting animal welfare for the County of Los Angeles. We respectfully urge your support for the Motion.
