**Adoption of the Mental Health Commission Bylaw Amendments
(Supplemental Agenda Item 71-B)**

Dear Supervisor Barger:

I am writing on behalf of the California Association of Alcohol and Drug Program Executives, Inc. (CAADPE) regarding your motion to adopt the Mental Health Commission Bylaw Amendments, which is scheduled for discussion by the Board of Supervisors (BOS) on Tuesday, December 17, 2024.

CAADPE acknowledges and appreciates the motion to amend the bylaw to include six (6) out of nineteen (19) seats for substance use disorder (SUD) representation. However, we believe that SUD representation should ideally be closer to 50%. We respectfully request that the BOS consider increasing the number of SUD seats to better represent those in need. If this is not feasible, we urge each Board office to leverage your office seats on the commission to appoint individuals to this newly formed commission who represent the SUD community or possess substantial experience in both SUD and mental health advocacy. While there are shared objectives between the mental health and SUD fields, it is crucial to recognize the significant differences and specialized needs that require dedicated advocacy.

We concur that it is essential for the Behavioral Health Commission to expand its scope to include representation for co-occurring and substance use disorders. The field of substance use disorder has long advocated for parity, and it is imperative that we strive for equitable representation on this commission. Los Angeles County communities merit this consideration.
