Oppose	Deborah Enos	<p>I strongly oppose the contracting process that has resulted in the community of Rowland Heights being saddled with a waste hauling contract that put us at the highest monthly cost of all the communities in this action. The difference is between 8 and 14%. This is also after our community has suffered 15% increases year over year between 2019 and 2024. If this contract is allowed to go forth our community will see a 48% increase in cost over only 3 years. Is this appropriate and fair? Who is looking over our community?</p> <p>In checking my past Athens bills. Our rates have gone from \$28.41/ month in 2022 to the new proposed rate of \$41.84 in 2025. That's 48% increase over 3 short years!!!</p> <p>Additionally, the contract language also allows up to 25% increases year over year, at the discretion of Public Works based on "qualifying" reasons. As noted above, increases year over year have been approx 15% each of the last two years. Terrible!</p> <p>In reviewing the board report, I couldn't find what the bids were for our community from the other companies. Shouldn't this information be made public?
