His efforts to march for immigrant causes while Black children continue to suffer in underfunded schools and struggling neighborhoods are misguided. We need a leader who will prioritize the needs of our community, especially in areas like education, housing, and healthcare. His confused direction is unacceptable.

Our demands are clear:

To: The Los Angeles County Board of Supervisors Subject: Black People Deserve Full Reparations: Land, Money, Housing, and Economic Justice Now

Dear Honorable Members of the Board,

For centuries, Black people in America—especially in Los Angeles County—have been systematically robbed of wealth, land, housing, and opportunities. We built this country, yet we have received nothing in return but racial discrimination, stolen property, and economic oppression. It is time to give Black people what is rightfully ours.

Los Angeles County has the resources to fund policing, corporate incentives, and billion-dollar developments—there is no excuse not to fully fund reparations for Black residents.

1. Direct Reparations for All Black Descendants

We are no longer asking. We are demanding full reparations NOW, not in studies, not in promises, but in real, tangible compensation. We demand:

? Direct payments of at least \$5 million per Black descendant, recognizing stolen labor, land, and wealth.

Los Angeles County pours millions into child services while doing little to actually support and uplift Black families. Instead of funding separation, we demand that money be used to keep families together:

- ? Direct cash assistance to Black parents, ensuring financial hardships do not lead to unnecessary child removals.
- ? Free, high-quality childcare for all Black families, removing barriers to employment and education.
- ? County-funded family healing and reunification programs, led by Black professionals and community members—not government bureaucrats. ? A freeze on all forced adoptions of Black children, preventing agencies from permanently severing Black family ties for profit.

We refuse to allow these agencies to profit off Black suffering while claiming to "help."

3. Reparations & Economic Justice for Black Families

Government policies created Black poverty. Government policies must fix it. Reparations are not a suggestion—they are a demand. We demand:

- ? Direct, no-strings-attached reparations payments to all Black families who have been impacted by DCFS, police overreach, and discriminatory policies. ? A \$5 billion Black Family Restoration Fund, providing financial relief, legal aid, and family reunification support for Black residents.
- ? Free housing, utilities, and healthcare for Black families, ensuring stability and security after centuries of economic oppression.
- ? A legal guarantee of land and homeownership for Black descendants, reversing decades of racist housing discrimination.

Black families deserve to build wealth, security, and legacy—not struggle under a system that was designed to keep us oppressed.

4. End the Criminalization of Black Parenthood

Black parents should not have to live in fear that a social worker or police officer will come and rip their children away for being poor, struggling, or simply being Black. We demand:

Dear Board of Supervisors:

On behalf of APLA Health, I am writing in opposition to and with significant concerns about today's motion, *Approval to Execute 17 New Contracts for the Provision of Core HIV Medical Services*. While we strongly support the provision of Core HIV Medical Services, and as an awardee and longstanding provider of these services are eager to continue offering the portfolio of Ambulatory Outpatient Medical (AOM), Medical Care Coordination (MCC), and Patient Support Services (PSS) to our clients and patients, we have significant concerns about the large disparity in funding levels based on the respective number of patients living with HIV that are served by each awardee.

As some background, APLA Health (formerly AIDS Project Los Angeles) restores dignity and trust within underserved communities by providing world-class LGBTQ+ empowering healthcare, HIV specialty care, food, housing, and other essential support services. Since our founding in 1983, APLA Health has remained steadfast in our commitment to ending the HIV epidemic in our lifetime. We operate eight Federally Qualified Health Center (FQHC) locations in Los Angeles County, serving more than 19,000 people annually, regardless of ability to pay. Our list of comprehensive services includes LGBTQ+ primary care, dental care, behavioral healthcare, HIV specialty care, and Out Here Sexual Health services (PrEP, STD screening & treatment, DoxyPEP, and PEP). For people with HIV, our wraparound support services include housing assistance through the Alliance for Housing & Healing and nutritional support via the Vance North Necessities of Life Program, the largest food pantry in the United States for people with HIV, distributing over 800,000 meals annually. We are also leaders in advocating for policy and legislation at the local, state and Federal levels that positively impact the LGBTQ+ and HIV communities.

APLA Health met with the LA County Department of Public Health's Division of HIV and STD Programs (DHSP) on January 29, 2025 to express our concerns and request more detailed information about the funding formula used for this solicitation. We discussed the provisions of AOM, MCC, and PSS services, historic challenges and successes of this service category, and differences in health center and patient characteristics of the various FQHC awardees, including APLA Health.

We also reviewed HRSA Uniform Data System (UDS) data for each of the federally qualified health centers (FQHC). APLA Health compiled a matrix showing the number of FQHC patients living with HIV for each of the awardees, each FQHC's Core Medical Services award amount, and calculated the award amount per patient. A copy of the data is included as an attachment to this letter. In particular, we expressed concerns that the Los Angeles LGBT Center received approximately 2.2 times more than APLA Health's award, while, according to UDS data, they only serve approximately 1300, or 1/3 more patients living with HIV than APLA Health. Note that we do not have access to similar data for non-FQHC awardees so could not include them in our comparison.

APLA Health also requested to see a breakdown of each awardee's funding by service category. The funding chart provides an aggregate award amount for AOM, MCC, and PSS under the umbrella of Core HIV Medical Services, but we indicated to DHSP that it would be helpful to see how much awardees were granted for each individual service to better understand award levels. DHSP indicated that they would inform awardees that they would distribute this additional award information, but to date, this information has not been distributed. We remain concerned about the rationale behind the award amounts, and for this reason, currently oppose this motion.

Given that the motion is on the Consent Calendar for today's meeting, we request that the Board of Supervisors direct DHSP to immediately release a breakdown of the Core Medical HIV Services awards by service category (AOM, MCC, and PSS). Additionally, we request that the Board Offices' health deputies meet with APLA Health to review this additional information and discuss opportunities for awards to accurately reflect the patients served and needs of each awardee, whether by retroactive changes to award amounts, delegated authority amendments, or other approved methods.

We again thank the Board of Supervisors for their ongoing commitment to serve people living with HIV in LA County and support the organizations that provide these services.
