FOR ALL DEPARTMENTS ESPECIALLY PUBLIC DEFENDERS I hope this letter finds you well. As the appointed Arts in Public Places Advisory Commissioner since 2019, I am writing to express my deep concern regarding recent findings that highlight unconstitutional activities within our city's law enforcement union. These activities not only undermine public trust but also pose significant threats to the safety and well-being of our Hispanic and Chicano communities in their schools. workplaces. and homes.

Urgency of Research and Development

In my capacity as Commissioner, I have been dedicated to fostering cultural enrichment and community engagement through the arts. However, recent research indicates systemic issues within our law enforcement that adversely affect the very communities we aim to uplift. It is imperative that we address these concerns promptly to ensure that our initiatives are not overshadowed by misconduct and to maintain the integrity of our city's commitment to its residents.

Unconstitutional Activities Identified

Investigations have revealed instances of misconduct among certain members of our law enforcement. Such actions not only violate the constitutional rights of our citizens but also erode the foundational trust between the community and those sworn to protect it. Notably, the 1992 Kolts Commission Report identified the presence of deputy gangs within the Los Angeles County Sheriff's Department, particularly in areas predominantly occupied by minority groups. Applicable Laws and Enforcement Measures

To address and rectify these issues, the following legal frameworks can be enforced:

California Penal Code Section 832.5: Mandates that each law enforcement agency establish a procedure to investigate complaints against its personnel. This ensures that allegations of misconduct are thoroughly examined and appropriately addressed.

California Penal Code Section 148.6: Affirms the right of individuals to file complaints against police officers for improper conduct and requires agencies to have procedures in place to investigate such complaints. CODES.FINDLAW.COM

California Penal Code Section 13510.8: Allows for the consideration of a peace officer's prior conduct and service record in evaluating whether to revoke certification for incidents under investigation. LAW.JUSTIA.COM

Recommended Actions

In light of these findings, I urge the following actions:

Immediate Investigation: Initiate a comprehensive investigation into the alleged misconduct within our law enforcement agencies, ensuring transparency and accountability throughout the process.

Policy Implementation: Develop and enforce policies that prevent misconduct, promote ethical behavior, and protect the constitutional rights of all residents.

Community Engagement: Foster open dialogues between law enforcement and the Hispanic and Chicano communities to rebuild trust and ensure collaborative efforts in maintaining public safety.

Training and Education: Implement regular training programs focused on cultural competency, constitutional rights, and ethical policing to prevent future instances of misconduct.

By taking these steps, we can uphold the principles of justice and equality that our city stands for and ensure the protection and prosperity of all our residents.

Thank you for your attention to this critical matter. I am committed to working collaboratively to address these issues and am available to discuss further actions at your earliest convenience.

Key programs such as Specialized Treatment and Optimization Programming (STOP), the Care First and Community Investment Program (CFCI), and LA County Training Center (Firefighter Training Program) play a crucial role in providing critical opportunities and support for individuals transitioning back into our communities.

These initiatives not only provide essential services to those who have been impacted by the justice system but also foster a spirit of rehabilitation and reintegration.

Over the past three years, the CFCI has successfully distributed significant funding to numerous Community-Based Organizations (CBOs) across various districts. This support has allowed these organizations to reach populations that may have otherwise been underserved, creating a more equitable landscape for community engagement and support. The assistance in managing insurance and County contracting processes has empowered these CBOs to thrive while delivering critical services. In order to continue to demonstrate these successful outcomes, additional funding for Year 4 is critical.

In light of the passage of Proposition 36, there is a significant need for increased funding to sustain and support these services in JCOD. This funding is essential to implement the necessary support systems and resources that will help individuals transition back into their communities successfully. By investing in JCOD, we are investing in a safer, healthier, and more equitable Los Angeles.

We would also like to see an investment in Warm Landing Place, the reintegration center they are trying to build across from Men's Central Jail that will provide a unique opportunity to ensure proper community transitions.

We believe that continued funding for JCOD will lead to long-term benefits for both justice-involved individuals and the broader community, ultimately contributing to a reduction in recidivism rates and enhancing public safety.

Thank you for considering our request to support the JCOD budget. We look forward to your continued commitment to fostering justice and opportunities for all residents of Los Angeles County.
