Los Angeles County Claims Board's recommendation: Authorize settlement of the matter entitled Christensen Brothers General Engineering, Inc. v. Los Angeles County Waterworks District No. 40, et al., Los Angeles Superior Court Case No. 20STCV35076, in the amount of \$295,000, and instruct the Auditor-Controller to draw a warrant to implement this settlement from the Department of Public Works' budget.

This breach of contract lawsuit seeks damages against the Department of Public Works for costs incurred on an improvement project for the installation of a water-main pipeline in Lancaster.
