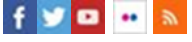

This is letter serves to bring to your attention that biotechnology tools, including biological agents and bio-responsive materials, may be mishandled by the



Los Angeles County Sheriff's Department (LASD).

The allegations include:

1. Destruction of Commercial Goods: Contamination or degradation of household products, wash water, clothing, and bedding items, leading to material and financial loss. Contamination of kitchen area, food, and utensils. Contamination of pet food.

2. Contamination of Environments: Improper use resulting in the pollution of wash water areas, posing risks to public health and the environment. (Resistant biological agents in toilet, sink, and bathtub.)

3. Facial Alteration as a Weapon: Use of biological tools to alter individuals' facial features, seemingly for purposes of humiliation, coercion, or control, which is an egregious abuse of power and technology.

4. Improper use in minors bedroom. (Bedding and clothing)

Such actions, if verified, represent a gross misuse of advanced biotechnological resources and a violation of ethical standards and public trust.

Furthermore, this is improper disbursement of payment for labor involving abuse. Immediate investigation and accountability measures are

necessary to prevent further harm and ensure responsibility.
