

**SUPPORT FOR GOVERNOR NEWSOM’S APPROPRIATIONS REQUEST**

On February 21, 2025, Governor Gavin Newsom sent a letter to the United States House of Representatives leadership outlining the financial needs of the County, City and State to support the immediate and long-term recovery of impacted communities. The Governor’s Supplemental Appropriations request, totaling \$39,680,737,878, would support business and workforce recovery, tax incentives, community and private property recovery and disaster resilience. On January 23, 2025, the County sent a letter to President Donald Trump requesting financial and legislative relief for fire recovery efforts. The County of Los Angeles continues to face significant challenges resulting from the impacts of the January 2025 wildfires, and is leading the swift rebuild and recovery of our communities and residents.

To mitigate local fiscal challenges, the County has submitted a 2025-26 Supplemental State Budget Request seeking \$900 million in revenue stabilization funding. While the County commits significant resources towards leading the recovery of impacted communities, this supplemental funding is critical to sustaining vital public services, including child and family services, healthcare, libraries, public works, solid waste management, and parks and recreation.

The needs and opportunities delineated in Governor Newsom’s letter outline the challenges and necessary investments the County is seeing each day. Significant repairs and modernizations to water, sewer, gas and electrical infrastructure are necessary to get residents back into their communities. Creative financing mechanisms and federal grant funding will be crucial to ensure all residents have the option to return to their homes. Local, state and federal partnerships are instrumental in protecting vulnerable communities from future disasters across Los Angeles County.
