Delayed Step-Down Facility: Instead of utilizing Kilpatrick, the plan proposes building a new step-down facility on the Barry J. campus. However, given Probation's historically slow pace, this delay would leave many young men stuck in the compound. Impact on Rehabilitation: Boys who could have been sent to Kilpatrick will now have to wait for the new step-down facility, despite Barry J. not being

			 designed to effectively prepare them for reintegration into society. Harmful Relocation for Girls: Sending young women to Malibu isolates them from their families and places them in a facility that was never intended for their needs, further disrupting their support systems and rehabilitation.

Dear Honorable Members of the Los Angeles County Board of Supervisors,

I am writing to express my deep concern about the potential disposal of toxic fire debris waste in my local landfill. As you are aware, wildfire debris often contains hazardous materials such as asbestos, heavy metals, and other toxic compounds that pose serious risks to public health and the environment.

Dear Board Members:

I have 2 major concerns about the recovery:

- 1. Premature blame of the electric company before conclusive evidence is available. Many are already stating that the electric company is to blame for starting the fire. This implies that the electric company is liable to pay for all the costs. If the electric company is guilty, it is just for them to pay. If guilty and made to pay all of us customers will have giant and unfair rate increases. It appears that the motivation for stating the electric company is guilty is so individuals can successfully sue the electric company and our government will be reimbursed for their costs. This becomes a social justice issue as those of us who were not impacted by the fire will end up paying the bill. This is even though the damage done was largely the fault of government not being prepared to fight the fire and it appears mistakes made in early fire fighting deployment and notifications.
- 2. Ability of individuals to access their property and do repairs themselves. It appears there has been restriction on access to property and impediments for property owners to begin their own repairs. This is just wrong. In my youth living on Chatsworth reservoir, I fought neighborhood fires with a shovel until the fire department came. When I got to high school and had a car, my friends and I would take shovels and join firefighters on the hand lines stop the brush fires. If I had tried to do that for the Eaton Fire I would probably have been arrested and jailed. This is upside down. Those of us trained and capable of protecting our communities should be allowed to do so. It is a lame excuse that there wasn't enough law enforcement to control us.

West Loma Alta WUI Fire Prevention Plan

Northwest Altadena needs a sustainable plan for fire control. As we learned on January 7th, we've been living with outdated and insufficient planning for fire prevention. There was little planning in place to lessen the risk, or intensity, and to fight wildfire in the neighborhood. It's essential that we do better in the future, to protect our neighborhood and to minimize the risks of fire spreading to our neighbors below. We need a plan to increase fire resilience through infrastructure improvements, landscape management, house hardening, and more. We're asking that the county help us to implement the changes that are needed to ensure northwest Altadena can be a habitable place in the future.

Landscape Management: There is not a sufficient program in place for maintaining the chaparral on the hillsides that border the neighborhood. The chaparral above our neighborhood spans both public and private lands. The chaparral fueled the fire as it roared into the neighborhood. We need a better plan for managing the landscape that finds a balance between the protecting the nature and ensuring the safety of the neighborhood. There are many strategies that we know can be effective- creating fuel breaks, removing dead brush, thinning the chaparral, removing invasive plants, targeted grazing, prescribed burns and more. Currently none of this is happening in the hills immediately above our houses.

Emergency Water Supply: We all know now that we had insufficient water sources on January 7th. We would like to study the idea of a supplemental emergency water source in the hills above the neighborhood, such as a reservoir, that could be used for wildfire control.

Undergrounding Power Lines: The power lines spark in high winds and pose an obvious and unnecessary fire risk. It's time we mandate they are buried.

House hardening: We need to build our homes more resilient and we want a fund to support neighbors in this effort.

Volunteer Firefighter Program: There were no firefighters protecting our neighborhood. We want the county to fund a volunteer firefighter program so we can receive the training we need to protect our neighborhood in the next fire event. This could also be part of a larger push for fire education for the community.

Nuccio's Nursery: Nuccio's hillsides span from Loma Alta park to Chaney Trail. These hillsides had no fire maintenance. The Nuccio family is looking to sell their property and we think there is an opportunity for the county to purchase this land and transform it into a model of fire prevention for the future. It's an ideal place for a reservoir. Or if it's purchased by a private entity, fire control needs to be mandated.
