Takeovers and sideshows have been occurring in my community since 2019 and I am grateful to Supervisor Mitchell and the Street Takeover Reduction Workgroup's Action Plan to reduce or eliminate this illegal activity and bring peace back to our communities. My life change on 2019 when 2 iresponsible drivers decided to street race in my block and crashing into and innocent young lady

by the name of Bethany Olguin. I ran out when the loud sound than more than a crash it sounded like an explosion. As I was approaching the vehicle I immediately when over to Bethany's car since the guy that was racing got out of hes car like nothing and took off on the other vehicle that was racing with him. Bethany was alive only for few minutes then she passed away before paramedics arrived. I didn't know Bethany but that day I met her when I approached her car she looked at me and asked for help. Along with Bethany was her brother he was also seriously injured, but survived. Bethany left a daughter that at the time she must of been 5 years old. The person that cause the accident was found 2 month later and only sentence to 3 years in prison. Ever since street racing and street takeovers have increased drastically.

I urge the Board to approve this motion so that we can comprehensively address the issue and hold those who promote it accountable. Thank you."
