			Daphnee N Rodriguez	Hello, my name is Daphnee, and I am a USC Keck medical student and also a volunteer caseworker with Project HCV Connect. I'm writing to urge your continued support in addressing the public health crisis that is hepatitis C. Each year, tens of thousands of people in the U.S. die from hepatitis C—a disease that is fully curable when diagnosed and treated early. These deaths are not due to a lack of medical innovation, but rather to broken systems that fail to educate, link, and support individuals through treatment. In my role as a volunteer caseworker with Project HCV Connect, I reach out to people in LA County who are living with hepatitis C. Many are ready and motivated to start treatment once they learn about their options—but they still face barriers. These include lack of insurance support, delays in communication, and challenges navigating the healthcare system. As a Keck USC medical student, I volunteer my time to do this work through Project HCV Connect. Despite the dedication of our volunteer team, we are still trying to reach people who tested positive more than a year ago. We simply do not have the staffing or infrastructure to provide timely follow-up and connection to care. We need full-time, paid case managers and a system that can proactively track and support patients through treatment. That is why I strongly support the motion passed in June 2024 directing the Department of Public Health and the Chief Executive Office to assess the feasibility of expanding hepatitis C care coordination by adding 2 full-time paid staff members within the department of public health to focus on Hepatitis C linkage-to-cure. I also urge broader support for expanded treatment assistance and care resources for all residents living with hepatitis C in LA County. We have the tools to cure hepatitis C. Now we need the systems and staff to make that cure accessible to all.
