# Re: Letter in SUPPORT of Ensuring Access to Education for Immigrant Students Agenda Item 20, Recommendation Submitted by Supervisors Solis and Mitchell

## For the Board's May 6, 2025 Meeting, Agenda Item No. 20

To the Distinguished Members of the Board of Supervisors:

On behalf of Bet Tzedek Legal Services, we write in strong support of Agenda Item No. 20, the recommendation entitled Ensuring Access to Education for Immigrant Students. We appreciate the Board's intention of ensuring education access for immigrant students and would like to offer ourselves as a resource based on our connections and experience in the community, as well as our deep subject matter expertise.

## Bet Tzedek has Deep Experience Striving for Justice for Our Immigrant Communities

For over 50 years, Bet Tzedek has provided free legal services and counsel to low-income residents of Los Angeles in a comprehensive range of practice areas including Elder/Caregiver Law, Employment Rights, Guardianships, Health, Holocaust Reparations, Housing, Public Benefits and Impact Litigation. An important part of this work includes Bet Tzedek representing undocumented minors in probate courts seeking the appointment of a legal guardian and in obtaining the predicate findings related to Special Immigrant Juvenile Status (SIJS); we also assist in their immigration matters, filing affirmative petitions as well as providing representation in removal proceedings. Additionally, Bet Tzedek also contracts with the Los Angeles County Department of Children and Family Services to provide immigration representation to foster youth eligible for SIJS. Lastly, Bet Tzedek also provides private and legal aid attorneys throughout the state with training, mentoring, and technical assistance on the probate legal guardianship process and SIJS law to increase the capacity and quality of legal services committed to the population eligible for SIJS.

#### Agenda Item 20 is an Important Step in Promoting Education Access for All Students

We support Agenda Item No. 20. This is an important step in encouraging education access for all students, particularly given California's history. For example, in 1998, Prop 227 passed by a wide margin, which mandated English-only education in all California classrooms and essentially prohibited students from immigrant homes from leveraging their existing language skills to access classroom contact. While Prop 227 was overturned by voters in 2016, its impact can still be felt in the lack of resources and in the bilingual teacher shortage. In addition, LAUSD recently reversed its previously

established "sanctuary schools" policy, concerned that using that label could make it a target of the federal administration. This puts the responsibility on individual schools to understand and communicate their constitutional rights to students, families, and federal law enforcement.

Accordingly, we support the call for a 2-week survey of school districts in the County and a report back with plans on alternative learning options, Know Your Rights trainings, technical assistance plans, mental health service plans, and other alternative instruction plans to support educational access for immigrant students. In particular, we would like the report back to highlight alternative instruction options and Know Your Rights education, as these options are concrete steps to being able to more meaningfully access education for all students in these turbulent times, especially for immigrant students and their parents, who face a real possibility of detention or deportation through merely the simple act of going to school. And, we urge the County to analyze the report and translate the recommendations into meaningful action to ensure educational access for all students.

#### Bet Tzedek Would Like to be a Resource for the County in Immigration Justice Issues

Accordingly, we would like to offer ourselves as a resource. Bet Tzedek regularly partners with individual schools, school districts, library systems, municipalities, and other public institutions to provide legal education in response to the ever-changing immigration policies and enforcement actions. Additionally, we regularly meet with school children who are worried about their families and themselves given the anti-immigrant rhetoric and removal efforts from the federal administration. We provide Know Your Rights presentations to arm minors with critical information about interactions with immigration enforcement agents and how to exercise their rights therein. Similarly, we provide Family Preparedness Presentations to educate undocumented and mixed-status families with information about real, tangible options should one or both parents be detained or removed. Relatedly, we hold workshops to assist parents in drafting and executing legal documents to effectuate their plans of care for their children, should the need arise as a result of deportation. In this year alone, we have been approached by LAUSD and many individual schools for Know Your Rights Presentation support, and we are always happy to provide technical assistance or insight on any immigration justice issues.

Bet Tzedek appreciates this Board's intention to address immigrant justice and educational access for immigrant students and encourages a continuation of this valuable work. Passing this recommendation is an important step forward in creating a more equitable and effective response to ensuring access to education for immigrant students in Los Angeles County, and we encourage the Board's support of this recommendation. California's future depends in large part on our children and, as such, protecting them and working to provide equitable educational access is an investment in our tomorrow.
