As a resident of the South Bay and located just 2 miles from the proposed site, I understand the urgent need for comprehensive and sustainable solutions to homelessness in our community.         The city has demonstrated a willingness to find solutions with the temporary shelter located near city hall. Permanent supportive housing is the next right step to provide more stable and long-term housing solutions for our neighbors in need. With the high cost of housing in the South Bay, many people are just a missed paycheck, medical bill, or lost job away from homelessness, especially those who are renters or on fixed incomes. The annual homeless counts in SPA 8 reveal a rise in senior and family homelessness each year. Local work is being done, but we need all pieces of the puzzle in place to make a meaningful difference.         Permanent supportive housing such as the Moonstone Homekey project in Redondo Beach and the Proposed Homekey Project in Torrance operate on Housing First models with strict resident agreements, enrollment criteria, security, and support services. This location is ideal for future residents, near local bus routes, job opportunities, and city services. I think that the city's reaction and opposition to this project is unfounded, and largely based on grievances that they were not fully notified or engaged in this application. I hope the city works with the county to define parameters for the project by which they can work together to support and move it forward.

**Correspondence Received** The following individuals submitted comments on agenda item: Position Name **Comments** Dear Chair Barger and Members of the Los Angeles County Board of Favor Hope Johnson Supervisors, I am writing as a resident of Torrance to express my full support for the proposed Homekey+ project at 3525 Torrance Boulevard, and my complete disagreement with the City of Torrance's opposition and the recent letter sent by Mayor George Chen. It is incredibly frustrating to see our city leadership once again lean into fearmongering and harmful stereotypes about unhoused people. The reality is clear: housing insecurity is driven by skyrocketing rents, cost of living, and insufficient affordable housing, not by personal moral failure. Mayor Chen's framing — which suggests unhoused people are a danger or burden — is misleading, stigmatizing, and deeply disappointing. Evidence-based policy tells us that housing-first approaches work. People need a stable, secure place to live before they can address challenges like employment, health, or addiction. It's disheartening that our city council unanimously opposed a project that would provide exactly that: dignity, housing, and support to people in need.

> As a member of this community, I welcome the Homekey+ project and encourage the County to move forward boldly. We need more permanent supportive housing, not less. And we need leadership that doesn't cave to classist scapegoating or economic fear tactics.

Torrance has a responsibility to be part of the solution — and that includes stepping up to support regional efforts like Homekey+. In fact, I would like to see even more action, including: Expanding affordable housing and supportive housing options Considering rent stabilization policies Creating incentives for housing development and disincentives for vacancy (e.g., vacancy taxes and limits on short-term rentals) This project is a small but meaningful step in the right direction. Please know that not all Torrance residents agree with the city's stance — many of us are ready to be compassionate, realistic, and proactive when it comes to addressing homelessness.

We did not receive any direct notice, such as a letter, which should have been sent to all impacted residents. As a result, we had to scramble to attend an emergency meeting on the evening before Memorial Day weekend just to gather basic information about the project. This lack of proper notification is a serious violation of the principle that all affected community members should be adequately informed about developments that impact them. Second, as residents of this neighborhood, we are deeply concerned about the negative impact it could have on our community. This area has been a safe, vibrant place for our children to grow up, with convenient access to libraries, city pools, theaters, Del Amo Mall, and a variety of restaurants-all within walking distance. Some community members spoke compassionately about the need to provide housing for seniors-those on fixed incomes, aging into poverty, or just one medical bill away from homelessness. I agree. That kind of housing: dignified, stable, and responsibly supported, is likely something most people in Torrance are willing to stand behind.

But the concerns raised by residents, particularly around safety, are not about helping seniors. They are about the very different challenges posed by untreated mental illness, addiction, and behavioral health issues that require a much higher level of care, structure, and accountability. This is not about stigma. It's about recognizing that different populations require different solutions.

To the County's credit, this proposal includes supportive services. But services alone do not solve the problem of location. The proposed site is in the heart of one of Torrance's busiest commercial corridors—adjacent to the Del Amo Fashion Center, local businesses, schools, and family neighborhoods. Even with services, placing a high-density site here for residents with potentially complex needs is a planning mismatch. This isn't just about offering help—it's about offering help in the right way, in the right place.

I also want to address something stated by staff from Supervisor Hahn's office: that residents would sign leases. In traditional housing, a lease implies structure—screening, terms, enforceable rules. In supportive housing, those implications often don't apply. Saying "they'll sign leases" may reassure the public on the surface, but in practice, it doesn't mean what most residents assume it does.

There's also a much larger issue of sustainability. Permanent supportive housing means exactly that—permanent. But what's not being made clear is how this will be funded long term. Who pays for staff? For mental health services? For ongoing maintenance and case management? If the capital costs are covered by Homekey+, but no operational funding is guaranteed, what happens a year or two from now, or 10 years from now? That question deserves an answer before this is approved.

Let me also be clear: Torrance has already stepped up. We've built the 3290 Housing Village. We've cleaned encampments. We've helped house numerous people and conducted extensive outreach. We are not saying "no" to being part of the solution—we are the solution. But what's being asked here is not fair, not clear, and not strategic.

I respectfully ask the Board to delay approval until the following conditions are addressed:

A clear plan for who this site will serve, how they'll be screened, and how services will be matched to their needs.

Transparent explanation of lease terms, resident accountability, and enforcement procedures.

	2025 7:00:03		George Chen	Dear Chair Barger and Members of the Board: On behalf of the City of Torrance, I am writing to formally express our opposition to Los Angeles County's intent to submit a joint application to the State of California for Homekey+ Program funding for the proposed permanent supportive housing project at 3525 Torrance Boulevard, the site of the existing Extended Stay America Hotel. The City of Torrance continues to demonstrate its commitment to addressing homelessness through a range of proactive measures. These include a dedicated Street Outreach Program with full-time City outreach coordinators and the operation of the 3290 Temporary Housing Village, a 40-unit interim housing facility the City designed, developed and oversees within the Torrance Civic Center. Combined, these initiatives have helped over 1,100 individuals access services, housed more than 80 people permanently, and resulted in the successful resolution of dozens of encampments. We are proud of these outcomes and continue to support regional solutions grounded in compassion, accountability, and collaboration.

However, the County's proposed Homekey+ project presents a number of significant concerns that have not been meaningfully addressed. Situating 120 units of permanent supportive housing in such close proximity (750 feet) to the Torrance Civic Center and 3290, raises legitimate questions about the long-term sustainability of such an intensive concentration. The scale of the project increases the risk of overburdening on-site support systems and complicates efforts to ensure integration with the broader community.

Additionally, the project site lies directly adjacent to the Del Amo Fashion Center—one of the region's most prominent retail destinations—and is surrounded by restaurants, hotels, and other service-based businesses. The introduction of a high-density supportive housing facility in this location may result in unintended consequences for local commerce, consumer behavior, and the economic vitality of this commercial hub.

There are also pressing concerns related to public safety and the capacity of local services. The County has not clearly outlined how case management, emergency response, or ongoing operational responsibilities will be funded or shared. The City has already conveyed that the Torrance Public Housing Authority does not have the budget authority to provide project-based vouchers as doing so would require revocation of existing tenant-based voucher participants. Without coordinated interagency planning and guaranteed support, the burden of these critical services may fall disproportionately on the City of Torrance's police, fire, and human services departments.

Perhaps most concerning is the absence of any meaningful local engagement during the planning of this project. Torrance residents were not consulted at any stage, and community stakeholders have had no opportunity to provide feedback. This lack of transparency and collaboration is inconsistent with the principles of good governance and undermines trust in regional decisionmaking processes.

Recognizing the importance of this issue, the Mayor and Council held a Special City Council Meeting on Friday, May 23rd and heard from dozens of residents that expressed concerns with the County including the Torrance location in their application. The City Council voted unanimously to not support this location and against the Board including the Torrance location in their pending HomeKey+ application. For these reasons, we respectfully urge the Los Angeles County Board of Supervisors to reconsider the inclusion of the Torrance site in the Homekey+ application and welcome discussion between the Board and Torrance City Council. The City of Torrance remains committed to being a constructive partner in identifying appropriate, effective, and locally supported solutions to homelessness—but this particular proposal, as presented, does not reflect a viable or responsible path forward.

Despite the project's size and proximity to Del Amo Fashion Center and adjacent clinics, there was no documented Torrancespecific outreach or neighborhood workshop before the Board vote—undermining public confidence and missing local insights that could have identified critical concerns. Key technical studies also seem to have been omitted: such as traffic-impact, parking analysis, and capacity of bus routes, and if stops can accommodate the additional daily transit. Beyond process, the site itself is too cramped to meet buffering and design best practices. At just over half an acre, this former motel sits only two blocks from the mall and lacks any formal buffer from sensitive uses like nearby schools or parks. Have any studies been done in this regard. The Board materials included no details on site-security or operations plan-no staffing ratios, security protocols, nor tenant-selection policy-raising serious questions about long-term management and safety. Converting a small retail property into a large congregate shelter without these fundamental studies and community inputs feels rushed, and it risks creating unintended impacts on both neighboring homes and the businesses we all rely on. I request the board to re-consider its decision and perform additional due diligence including community outreach and meeting buffering best practices. If the board considers enough diligence has been done then, pursuant to the CPRA act and the Brown Act, pls share copies of all documents and communications regarding the evaluation of alternative sites for the Homekey + project that culminated in selecting 3525 Torrance Blvd, including but not limited to site-selection matrices, feasibility studies, scoring rubrics, and email correspondence between County staff and the Board. As well request that the board include in its agenda a future item to report back on alternative sites considered for Homekey+ in Torrance, including a comparative analysis. 

Given California's budget issues, there are better cost effective ways to deal with treatment. Housing could be built to improve affordability by discontinuing the use of Vehicle Miles Travelled as a criteria. This is completely inconsistent with the increase in green energy production and continued electrification of California automobiles. I strongly oppose the inclusion of 3525 Torrance Boulevard in the City of Wentao Shang Torrance as part of this application. This location is right in the heart of a very vibrant neighborhood within the center of the city of Torrance, next door to the office of Providence Pediatrics, across the street from Children's Hospital Los Angeles, within walking distance to two pediatric dentistry offices, two church facilities, a number of hotels. lots of restaurants and small businesses, not to mention the Torrance Civic Center, Katy Geissert public library, a number of parks, schools, and preschools that are 1-2 blocks away, as well as the famous Del Amo Fashion Center. Such a location is probably one of the worst places across the whole South Bay area for hosting a 120-unit housing facility for the Homekey+ program, which is designated for people with mental health issues and substance abuse (hcd.ca.gov/grants-and-funding/homekey-plus). What I find most disappointing is how poorly this project has been communicated with the local community. On behalf of the City of Torrance, I am writing to formally express our opposition to Los Angeles County's intent to submit a joint application to the State of California for Homekey+ Program funding for the proposed permanent supportive housing project at 3525 Torrance Boulevard, the site of the existing Extended Stay America Hotel.

The City of Torrance continues to demonstrate its commitment to addressing homelessness through a range of proactive measures. These include a dedicated Street Outreach Program with full-time City outreach coordinators and the operation of the 3290 Temporary Housing Village, a 40-unit interim housing facility the City designed, developed and oversees within the Torrance Civic Center. Combined, these initiatives have helped over 1,100 individuals access services, housed more than 80 people permanently, and resulted in the successful resolution of dozens of encampments. We are proud of these outcomes and continue to support regional solutions grounded in compassion, accountability, and collaboration.

However, the County's proposed Homekey+ project presents a number of significant concerns that have not been meaningfully addressed. Situating 120 units of permanent supportive housing in such close proximity (750 feet) to the Torrance Civic Center and 3290, raises legitimate questions about the long-term sustainability of such an intensive concentration. The scale of the project increases the risk of overburdening on-site support systems and complicates efforts to ensure integration with the broader community.

Additionally, the project site lies directly adjacent to the Del Amo Fashion Center—one of the region's most prominent retail destinations—and is surrounded by restaurants, hotels, and other service-based businesses. The introduction of a high-density supportive housing facility in this location may result in

unintended consequences for local commerce, consumer behavior, and the economic vitality of this commercial hub.

There are also pressing concerns related to public safety and the capacity of local services. The County has not clearly outlined how case management, emergency response, or ongoing operational responsibilities will be funded or shared. The City has already conveyed that the Torrance Public Housing Authority does not have the budget authority to provide project-based vouchers as doing so would require revocation of existing tenant-based voucher participants. Without coordinated interagency planning and guaranteed support, the burden of these critical services may fall disproportionately on the City of Torrance's police, fire, and human services departments.

Perhaps most concerning is the absence of any meaningful local engagement during the planning of this project. Torrance residents were not consulted at any stage, and community stakeholders have had no opportunity to provide feedback. This lack of transparency and collaboration is inconsistent with the principles of good governance and undermines trust in regional decision-making processes.

Recognizing the importance of this issue, the Mayor and Council held a Special City Council Meeting on Friday, May 23<sup>rd</sup> and heard from dozens of residents that expressed concerns with the County including the Torrance location in their application. <u>The City Council voted unanimously to not support this location</u> and against the Board including the Torrance location in their pending HomeKey+ application. For these reasons, we respectfully urge the Los Angeles County Board of Supervisors to reconsider the inclusion of the Torrance site in the Homekey+ application and welcome discussion between the Board and Torrance <u>City Council</u>. # RE: Opposition to the City's Joint Application to the Homekey+ Program – Neighborhood Impact and Proximity to Schools

### Dear Members of the City Council,

I am writing to voice my **strong opposition** to the City's joint application and proposed participation in the **Homekey+ Program**, specifically as it relates to the selected site at Extended Stay America in Torrance.

As a resident and parent in this community, I am deeply concerned about the lack of public transparency, the rushed nature of this process, and the serious safety and livability impacts on families and children, particularly given the proposed site's proximity to multiple schools and youth-centered spaces.

### 1. Proximity to Schools and Youth Spaces

The selected location is within close walking distance to South Bay Academy, T.U.Y. Academy Afterschool Daycare, Marona Middle School, Victor Elementary

School, and Anza Elementary school to name a few, placing vulnerable students and young children near a facility that may house individuals struggling with mental health, substance abuse, or criminal histories — without sufficient safeguards in place. While supportive housing can be part of a compassionate response to homelessness, the placement of such a facility near school zones raises serious child safety and supervision concerns.

### 2. Neighborhood Safety and Livability

Residents in Torrance are already facing challenges related to crime and transient populations. Adding a high-density transitional housing site without adequate security plans, on-site management, or integration into local services may only **exacerbate safety concerns, strain local infrastructure, and decrease quality of life** for nearby homeowners, renters, and small businesses.

### 3. Lack of Community Engagement

Many residents — including myself — were **not notified or included in any meaningful discussion** prior to this application. Decisions of this magnitude, which can have long-lasting effects on neighborhood stability and property values, should not be made without robust community outreach, public hearings, and transparent review of program details.

### 4. Insufficient Site Planning and Oversight

There is **no clear plan for long-term oversight, public safety enforcement, or measurable success criteria**. Without these safeguards, we risk repeating the issues seen in other cities where poorly managed Homekey conversions led to neighborhood degradation, increased emergency response calls, and irreversible community decline.

For these reasons, I strongly urge the Council to:

- Withdraw the current Homekey+ application tied to this site and select an alternative location outside of our neighborhood;
- Avoid placing high-density supportive housing projects near schools, parks, or family-centered communities;
- Prioritize transparency by including residents, school officials, and local businesses early in the planning process for any future initiatives of this nature;
- And pursue solutions in areas better equipped to manage the complexities

# of transitional housing, with appropriate zoning, infrastructure, and distance from sensitive community spaces.

We all support thoughtful, humane responses to homelessness — but this project does **not belong in our neighborhood**. It is not the right location, and the community should not be forced to bear the consequences of a rushed, top-down decision. Thank you for your time and consideration.

This lack of transparency and collaboration is inconsistent with the principles of good governance and undermines trust in regional decision-making processes.

Recognizing the importance of this issue, the Mayor and Council held a Special City Council Meeting on Friday, May 23<sup>rd</sup> and heard from dozens of residents that expressed concerns with the County including the Torrance location in their application. <u>The City Council voted unanimously to not support this location</u> and against the Board including the Torrance location in their pending HomeKey+ application. For these reasons, we respectfully urge the Los Angeles County Board of Supervisors to reconsider the inclusion of the Torrance site in the Homekey+ application and welcome discussion between the Board and Torrance <u>City Council</u>. The City of Torrance remains committed to being a constructive partner in identifying appropriate, effective, and locally supported solutions to homelessness—but this particular proposal, as presented, does not reflect a viable or responsible path forward.

The site in question is situated in close proximity to schools, parks, residential neighborhoods, and local businesses — areas that could be significantly and negatively impacted by a facility of this nature.

This decision appears to have been made without adequate community engagement or transparency. Many local residents and stakeholders were not given a fair opportunity to participate in the planning process or express their concerns. This lack of communication erodes public trust and leaves many feeling unheard.

Furthermore, questions remain about how the County plans to ensure the safety, accountability, and successful integration of the facility into the surrounding community. Without detailed information on how the facility will be managed and how its residents will be supported, it is difficult to be confident that this project will achieve its intended goals without unintended consequences.

I urge the Board to pause this application, engage in meaningful dialogue with the Torrance community, and reconsider this location for the proposed Homekey+ project. Effective solutions to homelessness must be pursued — but not at the expense of community safety, cohesion, and transparency.

# Homekey+ A place to live — and thrive.

Housing stability is vital to mental health wellness and wellbeing. Safe, affordable housing, paired with supportive services to address behavioral health challenges, can provide California's most vulnerable residents with the foundation they need to thrive.

**Homekey+** is the permanent housing component of the Behavioral Health Infrastructure Bond Act, part of Proposition 1 passed by California voters in March 2024. With funding allocated from the Bond Act, the California Department of Housing and Community Development (HCD), in partnership with CalVet, will expand the successful Homekey Program and honor the State's long-standing commitment to housing veterans to help support the development of permanent affordable housing with supportive services for veterans and individuals with mental health or substance use challenges who are at risk of, or experiencing, homelessness.

## **PROGRAM OVERVIEW**

**Homekey+** will be modeled on HCD's successful Homekey program, which emphasizes the acquisition and rehabilitation of existing buildings, or other project types including new construction, that can be quickly converted or constructed for permanent affordable housing, generally within 12 months of award. Since its inception, Homekey has funded 250 projects and over 15,300 affordable homes. Homekey+ will move quickly by making awards on a rolling basis, as applications are received. Applications will be assessed on project readiness, experience in developing and providing supportive services to eligible prospective tenants/residents, funding commitments that provide long term sustainable support (particularly BHSA ongoing funding), and project location, among other criteria.

## ELIGIBLE USES

**Homekey+** will provide applicants the flexibility to take advantage of opportunities available within their specific communities that will result in the speedy acquisition and availability of new homes with a focus on cost containment. It will also finance new construction for projects that can be built quickly in a cost-efficient manner.

Examples of eligible uses include acquisition and rehabilitation of existing sites (e.g. hotels/motels, apartments), commercial properties, master leasing, new construction, and the purchase of affordability covenants.

Dear Members of the Los Angeles County Board of Supervisors,

I am writing to express my firm and unequivocal opposition to the proposed Homekey+ project at 3525 Torrance Blvd., the site of the Extended Stay America Hotel.

I live within one mile of this location, in Southwood Torrance, with my spouse and our three elementary school-aged children. Ours is a neighborhood full of young families, many of whom — like us — have made substantial financial investments in our homes, with prices in the \$1.5 million range. We did this with the expectation of raising our children in a safe, stable, and family-friendly environment. This project directly threatens that expectation.

The area surrounding Del Amo Fashion Center already faces persistent safety challenges. Incidents involving large groups of juveniles, violence, and disruptions have led to increased law enforcement interventions and the adoption of a chaperone policy. Placing a permanent supportive housing facility just blocks from this troubled area, with minimal community oversight and little transparency, is a serious misstep.

Equally important, Torrance is not ignoring homelessness. In fact, our city has implemented thoughtful, effective, and compassionate solutions — including the Tiny Home Village and partnerships with Harbor Interfaith. These programs are producing results without compromising community safety. The Homekey+ proposal disregards these successes and disrespects the unanimous opposition from the Torrance City Council and overwhelming concern from local residents.

Let me be clear: we are not opposing help for the unhoused. We are opposing an illconceived, poorly located, and community-disregarding project that will overburden already stretched police resources, put children and families at risk, and undo years of responsible, local progress.

Torrance residents will not quietly accept decisions imposed on our community by the County without proper engagement, support, or accountability. This project is the wrong fit for this location. I urge the Board to reject the Homekey+ application for 3525 Torrance Blvd. and allow Torrance to continue leading with local, proven solutions.
