23.		Favor	Tania Ibanez Virnig	The Probation Department has not taken the advice of the Probation Oversight Commission's (POC) recommendations for two years. I have attended several POC meetings, in which Probation department administrative officers appeared, and while they sometimes responded to request for information on the spot or promised to have the answers to questions at the next meeting, recommendations have been made by the POC through out the years which have been utterly ignored or put on the back burner. For example, Chief EPPs said at the POC meeting that she would have Probation staff review the files of all interred youth to determine whether some of them could be released early to their community to avoid overcrowding and lighten the workload of staff, but Probation never followed up to inform the POC as to how many of the youth were released because of this review or why they were not qualified for release. Epps is no longer with Probation Department and the Monitor in charge of DOJ's case noted that there has been a lot of turn over of leadership staff at Probation. Given that the Court has ordered Probation to depopulate, it is important that all options be considered including most importantly the recommendations of the POC.
