**APPROVAL TO ENTER INTO PAYMENT AGREEMENTS WITH 104 FEE-FOR- SERVICE  
INDIVIDUAL AND GROUP CONTRACTORS  
(ALL SUPERVISORIAL DISTRICTS)  
(3 VOTES)**

**SUBJECT**

Request approval to enter into payment agreements with 104 Fee for Service Individual and Group Contractors for services provided during Fiscal Years 2020-21 through 2023-24.

**IT IS RECOMMENDED THAT THE BOARD:**

1. Approve and authorize the Director of Mental Health (Director), or designee, to prepare, sign, and execute an agreement, substantially similar to Attachment I, with 104 Medi-Cal Professional Fee-For-Service (FFS) Individual and Group Contractors (contractors) identified in Attachment II for Fiscal Years (FYs) 2020-21 through 2023-24. The total amount for FY 2020-21 is \$241,686, FY 2021-22 is \$254,866, FY 2022-23 is \$512,056, and FY 2023-24 is \$1,766,002, with an aggregate amount of \$2,774,610, fully funded by 2011 Realignment Mental Health revenue.
2. Delegate authority to the Director, or designee, to prepare, sign, and execute future amendments to the contracts in Recommendation 1 to: revise the boilerplate language; reflect federal, State, and County regulatory and/or policy changes provided that: the amendments are subject to the prior review and approval as to form by County Counsel, and Chief Executive Office Risk Management Division, as appropriate.

## **PURPOSE/JUSTIFICATION OF RECOMMENDED ACTION**

Approval of this request will authorize the Department of Mental Health (DMH) to pay claims for specialty mental health services (SMHS) provided during the term of the contract by 104 FFS contractors. DMH is the Mental Health Plan (MHP) for Los Angeles County as authorized under Welfare and Institutions Code Section 14712. As the MHP, DMH is responsible for the delivery of outpatient SMHS to clients throughout the County and maintains a network of contractors to meet this requirement. The 104 FFS contractors identified on Attachment II provided SMHS to members in accordance with their contract; however, during the contract term, the State Department of Health Care Services (DHCS) made changes to its Short-Doyle Medi-Cal claiming system causing some claims to be denied due to no fault of the contractors and inadvertently impacted the providers.

Board approval of Recommendation 1 will allow DMH to enter into payment agreements with 104 FFS contractors listed in Attachment II for services provided during FYs 2020-21 through 2023-24.

Board approval of Recommendation 2 will allow DMH to amend the agreements in Recommendation 1, as necessary.

## **Implementation of Strategic Plan Goals**

The recommended actions are consistent with the County's North Star 3, Realize Tomorrow's Government Today, via Focus Goal G.- Internal Controls and Processes strategy ii. Manage and Maximize County Assets.

## **FISCAL IMPACT/FINANCING**

The recommended action will authorize DMH to enter into payment agreements with the 104 FFS contractors listed in Attachment II to pay for approved services for FYs 2020-21 through 2023-24. The total aggregate cost is \$2,774,610, fully funded by 2011 Realignment Mental Health revenue.

The payment amount for each contract is listed in Attachment II and will be incorporated in substantially similar form into the financial exhibit of the payment agreement.

There is no net County cost impact associated with the recommended action.

## **FACTS AND PROVISIONS/LEGAL REQUIREMENTS**

On May 14, 2019, your Board authorized DMH to enter FFS Contracts with the 104 providers listed in Attachment II. During the contract term SMHS were provided and billed in accordance with the terms and conditions stipulated in the Contract. The FFS contractors were reimbursed by the MHP under the rules and guidelines established for Phase II Medi-Cal Consolidation which went into effect June 1, 1998. However, during the contract term DHCS deployed updates to its Short-Doyle Medi-Cal claiming system to ensure that DHCS was not reimbursing counties with federal funds for non-emergency and non-pregnancy related services provided to beneficiaries with unsatisfactory immigration status, resulting in the denial of all such claims, previously billed using a specific billing code. In 2022 DHCS informed Counties that they are responsible for the cost of nonemergency and non-pregnancy related services provided to those beneficiaries with unsatisfactory immigration status who would have been eligible for full scope Medi-Cal benefits prior to 2011 realignment. The Contract was structured for Medi-Cal billing only and did not include a mechanism for non Medi-Cal billable services. At that time, DMH was responding to the emergent needs arising from the

COVID-19 Pandemic to ensure continuity of necessary services. As such, it took a while for DMH to work with the 104 FFS contractors, confirm allowable claims for the denied billing code, and calculate final amounts. DMH is entering into payment agreements with the contractors listed in Attachment II. This is a onetime action.

After reviewing the Retroactive Contracts Board Policy 5.300, DMH determined that this action does not meet the definition of a Retroactive Contract as the services were provided during the contract term and did not exceed a contract sum as these contracts are reimbursed based on rates and the contracts do not include a total contract amount.

**IMPACT ON CURRENT SERVICES (OR PROJECTS)**

Approval of the payment agreements will not have an impact on current services or projects.

## **MENTAL HEALTH FINAL PAYMENT AGREEMENT**

THIS DEPARTMENT OF MENTAL HEALTH FINAL PAYMENT AGREEMENT ("Agreement") is made effective this XX day of XX 2025, by and between the County of Los Angeles Department of Mental Health (the "County" or "DMH") and \_\_\_\_\_ ("FFS Group/Individual Contractor"). County and FFS Grp/Ind Contractor are collectively referred to as the "Parties" with reference to the following:

### **RECITALS**

- A. WHEREAS, the County and FFS Grp/Ind Contractor entered into contracts for the provision of mental health services, including Medi-Cal covered services, for each of fiscal years ("FYs") 2019-20 through 2023-24, inclusive (the "Subject Fiscal Years");
- B. WHEREAS, the Welfare and Institutions (W&I) Code section 14712 directs the State to implement and administer Managed Mental Health Care for Medi-Cal eligible residents of the State of California. Section 14712 requires a contractual agreement between the State and the County for the County to operate as the Mental Health Plan responsible for the delivery of specialty mental health services to the County's eligible Medi-Cal beneficiary population;
- C. WHEREAS, on October 18, 2022 DMH entered into an Agreement with the Department of Health Care Services (DHCS) for the period of July 1, 2022 through June 30, 2027 whereby DMH will act as the MHP to provide outpatient specialty mental health services to all Medi-Cal members in Los Angeles County;
- D. WHEREAS, DHCS deployed updates to the Short-Doyle Medi-Cal claiming system during the term of the Contract to implement a new payment policy. Claims submitted using billing code CO 96 for Unsatisfactory Immigration Status were denied;
- E. WHEREAS, the Contractor provided outpatient specialty mental health services during the period of FY 2019-20 through 2023-24 and billed accordingly for said services in accordance with the invoicing terms of the Original Contract;
- F. WHEREAS, the Contractor was not paid for services rendered using billing code CO 96;
- G. WHEREAS, the County and FFS Grp/Ind Contractor each desire to document final amounts for each of the Subject Fiscal Years and to finalize payments between the Parties, in accordance with the terms and conditions below and in the accompanying exhibits;
- H. WHEREAS, each Party agrees that this Agreement is intended to avoid further delays in the finalization of payments for the Subject Fiscal Years and to avoid expenses associated with resolution of any individual request raised by FFS Grp/Ind Contractor with respect to those Subject Fiscal Years.

**NOW THEREFORE**, in consideration of these promises and the mutual covenants set forth herein, and for valuable and mutual consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties agree as follows:

## **AGREEMENT**

1. **Final Payments and Schedule.** The Final Payment and Schedule reflecting amounts owed to the FFS Grp/Ind Contractor from the County for the Subject Fiscal Years is attached hereto as **Exhibit A**. County and FFS Grp/Ind Contractor specifically agree that the payments identified in Exhibit A are the final payments for the Subject Fiscal Years and that no further adjustments will be made or proposed by FFS Grp/Ind Contractor, including as to any County, State, or Federal audits, except for cases of fraud. Payments identified on Exhibit A as due to the FFS Grp/Ind Contractor will be paid no later than 60 days following execution of the agreement, unless a different timeframe is agreed to by the Parties.
2. **Release of Claims.** FFS Grp/Ind Contractor on behalf of themselves, their predecessor and successor organizations, their employees and directors, whether past or present, agree to release, waive and forever discharge the County, its past and present directors, officers, employees, agents, managers, and any and all other persons or entities who have at any time acted, purported to act, or alleged to have acted on their behalf (collectively, "Releasees"), from any and all claims, lawsuits, arbitrations, causes of action, demands, liabilities, obligations, losses, damages, penalties, costs and expenses (including attorneys' and experts' fees and costs), of every kind and description, whether in law or equity, in tort, in contract, or under statute, known or unknown, whether or not previously raised to the County or the FFS Grp/Ind Contractor, arising from the FFS Grp/Ind Contractor's contracts with DMH for the Subject Fiscal Years related to the use of billing code CO96 (the "Released Claims"). For the avoidance of doubt, the Released Claims will include any and all claims, allegations, requests, issues, etc. that could have been raised by FFS Grp/Ind Contractor relating to (a) the amounts paid by the DMH to FFS Grp/Ind Contractor for mental health services provided in the Subject Fiscal Years; (b) any disputes arising from the submission or processing of claims for such services during the Subject Fiscal Years; and (c) any disputes related to FFS Grp/Ind Contractor contracts with the **DMH** related to the provision of mental health services during the Subject Fiscal Years. The Released Claims do not include the obligations stated in this Payment Agreement. The County and FFS Grp/Ind Contractor do not release their rights to protections previously obtained under earlier agreements.
3. **Noncompliance.** In the event of a material breach, the non-breaching Party must notify the breaching Party and, if the breach is not cured within 30 days of such notice, may bring an action to enforce the agreement pursuant to Section 10.
4. **Waiver of Civil Code Section 1542.** FFS Grp/Ind Contractor, for itself, and County, for itself, have each conducted their own diligent research regarding the Released Claims. This Agreement is expressly intended to release known and unknown claims, including all past, present and future rights of action related to the requests made by FFS Grp/Ind Contractor related to the Subject Fiscal Years,

and FFS Grp/Ind Contractor expressly waive application of Section 1542 of the Civil Code of the State of California, which provides as follows:

A GENERAL RELEASE DOES NOT EXTEND TO CLAIMS THAT THE CREDITOR OR RELEASING PARTY DOES NOT KNOW OR SUSPECT TO EXIST IN HIS OR HER FAVOR AT THE TIME OF EXECUTING THE RELEASE AND THAT, IF KNOWN BY HIM OR HER, WOULD HAVE MATERIALLY AFFECTED HIS OR HER SETTLEMENT WITH THE DEBTOR OR RELEASED PARTY.

The effect and import of this provision has been fully explained to FFS Grp/Ind Contractor and County by their own respective legal counsel.

5. **Authority to Enter into Agreement.** County and FFS Grp/Ind Contractor each represent and warrant that they have the full right, power, and authority to enter into this Agreement.
6. **Indemnification.** FFS Grp/Ind Contractor will indemnify and hold the County harmless from any claims, lawsuits, arbitrations, causes of action, demands, liabilities, obligations, losses, damages, costs and expenses (including attorneys' and experts' fees and costs), of every kind and description, whether in law or equity, in tort, in contract, or in statute, arising out of or in any way related to any breach of this Agreement.
7. **Complete Defense/Enforcement.** This Agreement may be pleaded as a full and complete defense to, and may be used as the basis for an injunction against, any lawsuit, arbitration, cause of action, demand, liability, obligation, or claim based on any loss, damage, cost and expense (including attorneys' and experts' fees and costs), of every kind and description, whether in law or equity, in tort, in contract, or in statute, or any other proceeding that may be instituted, prosecuted, or attempted, arising out of or in any way related to any of the Released Claims; provided, however, that this Agreement shall not preclude proceedings under Paragraph 10 below to enforce this Agreement's terms.
8. **Not an Admission.** This Agreement, and any negotiations or proceedings connected with it, will not in any event constitute or be construed as, or be deemed to be evidence of, an admission of or concession of any wrongdoing by any party hereto.
9. **Interpretation/Enforceability.** This Agreement has been negotiated at arm's length between parties sophisticated and knowledgeable in the matters dealt with herein. Each Party has conducted extensive due diligence regarding the Released Claims and has been represented by experienced and knowledgeable legal counsel. Any rule of law, including but not limited to California Civil Code section 1654, or any legal decision that would require interpretation of any ambiguities in this Agreement against the Party that drafted it is not applicable and is waived. The provisions of this Agreement will be interpreted in accordance with California law governing negotiated agreements between sophisticated parties who have conducted their own diligent research concerning the matters settled. Furthermore, after advice from experienced and knowledgeable legal counsel, all

parties and their counsel believe that this Agreement is legal and enforceable according to its terms and waives any and all rights they may have to claim otherwise to the maximum extent allowed by law.

10. **Applicable Law; Retention of Jurisdiction.** This Agreement will in all respects be interpreted, enforced, and governed by and under the laws of the State of California without regard to conflict of laws principles. Any action brought to enforce the provisions of this Agreement will be brought in the Superior Court of the State of California for the County of Los Angeles. The Parties expressly acknowledge and agree that this term will be treated as both a choice of law and venue provision.
11. **Entire Agreement/ Amendment.** This Agreement constitutes the entire understanding and agreement with respect to the Released Claims, and supersedes any and all prior or contemporaneous agreements, representations and understandings pertaining to the Released Claims. This Agreement may not be changed modified, altered or amended except by written amendment, in accordance with Paragraph 8.0 of the Original Contract, executed by the authorized representatives of the Parties named in the signature blocks below.
12. **Further Assurances.** Such further documents as may be needed to carry out the terms of this Agreement will be executed and delivered to the appropriate parties.
13. **Attorneys' Fees.** No Party will be liable for any other Party's costs and attorneys' fees incurred in connection with the Released Claims or the negotiation of this Agreement.
14. **Severability.** In the event any portion of this Agreement is declared void by a court such portion will be severed from this Agreement, and the remaining provisions will remain in effect, unless the effect of such severance would be to substantially alter the Agreement or the obligations hereunder, in which case the Agreement may be immediately terminated.
15. **No Waiver.** Any failure to insist upon strict compliance with any term, undertaking, or condition of this Agreement will not be deemed to be a waiver of such term, undertaking, or condition. To be effective, a waiver of any right hereunder must be in writing, signed and dated by the Party waiving the right.
16. **Recitals.** The recitals are hereby incorporated into this Agreement by this reference.
17. **Notices.** All notices required or desired to be given under this Agreement will be in writing and will be sent by email as follows:

18. **Third-Party Beneficiaries**. This Agreement will not create any third-party beneficiary rights for any person or entity; provided, however, that a Party will be entitled to assert the rights of a Releasee.
19. **Campaign Contribution Prohibition Following Final Decision in Contract Proceeding**. Pursuant to Government Code Section 84308, Contractor and its Subcontractors, are prohibited from making a contribution of more than \$250 to a County officer for twelve (12) months after the date of the final decision in the proceeding involving this Contract. Failure to comply with the provisions of Government Code Section 84308 and of this paragraph, may be a material breach of this Contract as determined in the sole discretion of the County.
20. **Survival**. County and Contractor agree that the sections listed below of the Agreement survive the termination and expiration of the Agreement. This paragraph will not be construed to imply that other provisions of this Agreement do not survive its expiration, if the parties intent, as demonstrated by language, circumstances, law, or practice, is that the provision should survive.
