We've had report backs from June 2024 and even April 2024, but since then there hasn't been an update on the clients and this motion is really coming due to the weekend before denim day. And I know that the board supported Denim day where we.

Uplift sexual assault awareness.

And and during that time, the Trump administration cut off funding to the national prison Rape Elimination Act Resource Center and the PRC.

It provides technical assistance as well as support for people who are incarcerated, who have been a victim or survivor of sexual assault.

So going back to the updates, we have not received any sort of current update from the progress of compliance. And my colleague Ali will talk a little bit about the report backs. Thanks, Esther.

In June of 2024 and the last one from the probation department was in April 2024 and the report back from probation. The department reported that was it was only 100% in compliance in four out of the 12 bigger standards for a total.

Of 70% compliance across all standards and then for the report back from the Sheriff's Department, the department was only in compliance with 19 out of 35 station facility pre categories.

It was actually for the most part, very effective, and I've served on national boards in law enforcement throughout the country where I talked to other police chiefs and sheriffs and we talk about oversight all the time.

And by the way, they have access to the majority of confidential records that we have.

The only thing they don't have access to is when we have an ongoing criminal investigation, and even then they will get.

Now we have Cal DOJ that the county is working with and we've been working with them for well over a year.

As we're discussing this with them, obviously the board, as you're all aware, has oversight of our budget that we work on with all of you and then.

The Board of State and Community Corrections has oversight over our jails, so as you see, just laying a foundation is that this is not just about oversight with one entity, but multiple entities and.

Responsibilities, but it is very important to realize as we are making decisions as a county family, that for each oversight body that I have named.

It is staff time.

And right now and I don't use this as an excuse, I'm in a staffing crisis for the Los Angeles County Sheriff's Department.

You've read about it this week because we had the tragic loss of one of my deputies and as a matter of fact, when I'm done here, I'm going to go back again with my executive staff to figure out a way to come up with staffing so I can.

Continuously reduce the mandatory overtime that we have.

So just please know more oversight.

More confidentiality as we're going to discuss that is more staff time in people.

That we have to apply because as you'll find is that a lot of times you have, for example, the Inspector General asking for certain reports. Some of these other entities will ask for.

I'm not going to say the same reports.

They're different, causing more staff time, so I just point made it takes a lot of work to get there.

The department does comply with requests for information.

We've worked with the Civilian Oversight Commission to provide them with information outside of the confidential request, so to give you an example, in 2023 they made 73 requests which contained approximately 3121 pages of work.

In 2024, we received 70 requests which we provided 1609 pages of responses or.

A request and 2025 year to date they have made 27 requests so far, 448 pages of materials have been provided.

That's just for the civilian oversight Commission. That doesn't include all the materials being requested from all the oversight bodies that we have over our department.

So just again, it's consuming to complete.

Frequently.

Or frequently, extremely time consuming.

To do this and then a lot of the requests like I said earlier, they do overlap, but differently. People are asking for different reports, same reports, but in different ways which causes more staff time.

So the issues around confidentiality, I know that the civilian oversight Commission is interested in obtaining materials that are considered confidential under state law.

It's not a choice that Robert Luna's making or the sheriff's Department's making, is what the the Civilian Oversight Commission is asking for is in conflict with state law.

So this has been going on for years.

And honestly, I think my my personal opinion is it makes us all as the county family look horrible.

Would probably take longer than we would all like through consulting with County Council, we came forward and basically asked for what we're calling a declaratory relief action.

From a leadership perspective, I think that was the best methodology to take.

Now I know that one of the questions on the table is that the board changed the ordinance.

But a judge has to make that decision because if I do it without that, I now am in jeopardy and sore all of us.

As a county family, because from a labor perspective, they're still meat confer, there's a lot of issues with our labor partners that have to be worked out to get through. A lot of this.

So there is a whole process ahead of us as as we move forward, just kind of reviewing my notes, I'm summarizing a lot of what I have here.

If you watch some of the the civilian oversight meetings at times, unfortunately.

There are statements that are made based on allegations and they come out as if they're factual, and I think in fairness to everyone involved, both our community members.

1st and our deputies.

I think there has to be a process where.

Somebody.

Public Safety CAR 28 minutes 36 seconds

In the Court of Law, and I know this isn't a court or the COC meeting's not a court.

A judge usually will keep people in check.

Within parameters of what can be said and not said.

Public Safety CAR 28 minutes 49 seconds

But I don't want to be in a situation where there's accusations being launched with very little or no facts.

Or evidence to support them.

But then they become headlines in the media and it's really unfair to everybody involved and I don't think for us as a county we should be performing or behaving that way.

And that was my last point.

May I add on to that code of conduct points and that is to say as as you know, you all are considering potential amendments to the ordinance and we're considering just generally the framework of how the civilian Oversight Commission performs this work.

I wanted to also.

Public Safety CAR 29 minutes 38 seconds

Bring up another potential change that might be coming that requires some really thoughtful consideration from a general oversight context, but also from a labor context.

But the that the sheriff has been raising and that's at AB 847 and I raised that specifically because that bill for the first time. And and I know that the bill was sought and supported by the Civilian Oversight Commission as an advisory body to the board.

And I wanted to note that that bill says, quote, it would give the COC access to personnel records of peace officers and custodial officers relating to the Commission's oversight duties.

It also requires that the Oversight Board shall maintain the confidentiality of these records consistent with section 832.7 of the Penal Code.

And I I'm raising this issue because currently this would be the first time if this bill passes that non county personnel would gain access to confidential county employee personnel records without an executed contract containing strong confidentiality provisions.

So, by way of background, I wanted to just make sure that everybody was in the same kind of foundation that.

Currently, for county employee records.

Public Safety CAR 30 minutes 54 seconds

Personnel records any county employee, all county employees who have access to those records, they can only gain access if they have an absolute need to know and even if they do have an absolute need to know, they can only access those records on county secured systems to ensure.

The security of those personnel records and they have to actually conduct themselves in a very specific way in terms of how they share those records.

Public Safety CAR 31 minutes 23 seconds

I raise that because we have nothing in place currently for the civilian oversight Commission to adhere to those same guidelines that we afford to every other county employee.

There is no code of conduct.

There are no laws in place that require the civilian Oversight Commission to conduct itself in the same way that our own employees need to conduct themselves. When looking at those same.

Kinds of personal records.

Public Safety CAR 31 minutes 51 seconds

So I raised the code of conduct issue because in the terms of coming up with thoughtful frameworks for oversight if.

Public Safety CAR 32 minutes 2 seconds

847 passes.

Public Safety CAR 32 minutes 3 seconds

That would be another component that would need to be thought through in addition to the fact that before we could actually implement that law, as we've seen with other laws that have been passed at the state, we need to actually meet and confer with our labor partners to.

Come up with how this.

Public Safety CAR 32 minutes 21 seconds

Would play out for those employees that are affected.

So and currently, none of our COC Commissioners are obviously county employees, just to continue the framework. They have not signed contracts with the county to maintain privilege or confidentiality of any documents that they receive.

They are not held to any standards of conduct, and it's my understanding that no Commissioners use county e-mail systems, nor do they use any other secured county systems when they are.

Looking at or potentially.

You know, viewing any kind of records, they may gain access to.

So.

As we're engaging in this thoughtful consideration of changes to the ordinance, it appears that with the potential for a V847 to pass, the county should potentially pause and think about the ramifications of that state law on any future ordinance changes.

Yeah. I'll just end by saying I think.

And and I believe in oversight. But I believe in good effective oversight. And I think for the board to consider that we have an opportunity to maybe modify and make some.

That it's not the way it is now.

It's just either rumor or somebody heard this that is not healthy for our community.

Thank you.

I know we want to hear from the COC, but before we invite them up, I do want to ask a question from Nicole based on what you were talking about with the bill.

Yeah. So in terms of what we have before us, right, the board letter that the COC has submitted, how is that similar?

How does that accomplish that?

No, I think it it does go into alignment with what 847 is trying to accomplish and it raises the real need for.

Or some kind of code of conduct or new rules via this ordinance that should be put in place for Commissioners so that Commissioners are held to the exact same standards as all other county employees when looking at or touching, having access to any kind of confidential personal records.

Or information. So the if say we we don't proceed with what's before us today.

And the legislature passes that would accomplish that same goal.

Correct. Without those protections in place, generally speaking there. I mean there are some some differences but but generally.

Is there anything hindering us from doing some of the prep work related to this bill or related even to this ordinance, right. I think you talked about the CLC not necessarily having, like the CLC e-mail or the Commissioners not having that the Code of conduct and some of.

These other pieces that they would need implementing, like the rules, I think a lot of times there's bills that are passed and then.

We're left trying to implement them right.

Is there anything we can do on the forefront in preparation for that?

The answer to the first question is absolutely yes. We can take the ordinance back and make some recommendations for your consideration. That would address the issues that were raised and try to bring folks into the to alignment with typical county process.

But it but it can be.

Is there any reason why you would need to take the entire ordinance back as opposed to moving forward with what's currently being discussed and you now starting to draft a new additional ordinance changes to address because the point because what you just walked through?

I mean a high level. How much?

Does it interplay with this? Is this feel like a relatively new issue?

Everything that has been going back and forth with the current draft from the Commission, how much is actually tied up.

That you need to pull back the whole thing.

Public Safety CAR 37 minutes 11 seconds

I mean, as the sheriff has expressed, there is.

A.

Public Safety CAR 37 minutes 15 seconds

A disagreement or a view on on the law as it relates to confidential peace officer records. If if we go with the cocs position on the amount of access that they would have to certain records, that would be those those records should be held in the same kind.

Of secure way and should be viewed and accessed in the same kind of secure way that all other county employees.

Public Safety CAR 37 minutes 40 seconds

Records are are viewed.

Public Safety CAR 37 minutes 43 seconds

Would be my recommendation and so along those lines I I think a code of conduct in in alignment with what the sheriff was talking about and in alignment with what the county expects of all of its employees would be beneficial and something that we could put in place.

Now I don't know.

I it looks like Tom was about to talk, so I don't want to interrupt.

No, I don't have any concerns what was just said, although just on that last point, I thought we heard very clearly from the sheriff, right, that it's state law that's preventing.

Him from sharing the documents.

So even if we passed all of this, I think the point he's making to us is we can pass all these ordinance changes.

He's still not sharing it until state law makes it clear.

Correct. But but to Natalia's point earlier, it would make sense and maybe behoove all of us to have frameworks in place so everybody understands the how they should be conducting oneself in a Commissioner role to protect everybody.

You know, Penal Code has certain kinds of pretty.

Serious penalties for folks who violate the Penal Code requirements and that would apply to to anybody who has access to those records and doesn't hold them in the method that they are required to be held under the law.

No, I don't think.

I don't think our questions are more about the sequencing of the pieces and whether everything needs to help be held up over this new mandatories issue or whether we can address different things, whether it'll be done, yeah.

But I I mean, I think you, unless you have more content.

I would like to make another point based on your questions.

So one of my arguments has been and maybe to the bigger, broader question about looking at oversight overall for the county is remember we're funneling information to the Office of Inspector General and then.

So for anybody who may think that no one outside of us has access to that confidential information, theoig does.

But yet there and for and he has his reasons. I'm not arguing with that, that he could give it to them, but he chooses not to.

Commission do you have anything to share?

Public Safety CAR 40 minutes 12 seconds

Add oh, I have a lot of confidence.

Public Safety CAR 40 minutes 14 seconds

Actually, I did a seat at the table last year.

So I heard you know what? Where to begin?

Public Safety CAR 40 minutes 32 seconds

Where? Where the sheriff left off. The IG is not withholding confidential documents from the civilian oversight to the Commission because he just won't give them to us.

Public Safety CAR 40 minutes 44 seconds

He's taking the same position the sheriff is taking, and that is if he provided the oversight Commission with confidential documents, it would violate state law, specifically Penal Code 832.7.

Public Safety CAR 40 minutes 56 seconds

And he would be subjecting himself to a misdemeanor prosecution.

Public Safety CAR 41 minutes

But the IG, by the way, doesn't take that lightly.

Public Safety CAR 41 minutes 2 seconds

Because the former sheriff actually investigate him for violating 832.7 so. So basically this. This would also be clarified in court that the IG would be able to give us confidential information just as a sheriff directly could give us confidential information under and frankly would.

Be compelled to do so under our subpoena power or independent measure. Our subpoena power.

Public Safety CAR 41 minutes 25 seconds

If if two things happen, one or two things happen. One the court decides.

That the that state law does permit.

Public Safety CAR 41 minutes 34 seconds

The Brown Act does permit the Civilian Oversight Commission to get confidential documents under subpoena if the court decides that and the Court should decide that we have a pending case right now in court.

But we'd like this to move forward.

Public Safety CAR 41 minutes 49 seconds

Get a judicial decision on that the other way it could happen is ABA 47.

Public Safety CAR 41 minutes 54 seconds

But let's not delay there.

I mean, there's no assurance whatsoever either.

47 is going to pass.

Public Safety CAR 42 minutes

It's being heavily lobbied by lads and other unions, representatives from law enforcement unions against that bill, but I don't. Whether it's going to pass.

We should certainly shouldn't be delaying things just because ABA 47 may pass the assembly, then it has to pass the Senate, and the governor has to sign it.

So you know, delay has been the hallmark here and we just want we want we want our revisions to be adopted by.

The board, we think they're all.

Provisions were taking it is true that there is a disagreement as to what the law provides with respect to whether or not the oversight Commission can go into closed session to receive confidential documents.

We say we can't.

Public Safety CAR 42 minutes 43 seconds

We think we have a very strong argument, legal argument.

Public Safety CAR 42 minutes 46 seconds

We can and we would like to make that legal argument in court.

As soon as possible, by the way, under the Declaratory relief action and under our enforcement action that will be filing soon.

So we'd like to make that argument in court.

We will be making that argument in court and the Court will decide it, and I I, you know, look, there's an argument.

County Council takes a different position, by the way. They're in conflict with the oversight Commission on this issue, but they take this different position.

I respect your position. I said that last time.

I respect the position of County Council.

Public Safety CAR 43 minutes 19 seconds

They're they're taking the most restrictive possible position with respect to the the Brown Act and whether or not the Brown Act permits the.

This will be an oversight Commission such as ours, with independence being authority to be able to go into closed session for purposes of receiving confidential documents. They say we can't. We say we can.

And by the way, it's I think we're entitled to some respect here too.

I respect County Council's position, but I'm in favour County Council to respect our legal position on this matter.

Where do you resolve disputes in Superior Court?

In and for the county of Los Angeles.

So we'd like this to go forward and we we think delay, you know delay has been the hallmark here of preventing really what is what is needed and what do they think the public wants and certainly what every Commissioner wants and and what we think the board wants.

Which is effective oversight and one thing the sheriff said.

I couldn't be more agreement with that.

He believes in good and effective oversight, and so do I.

We were in lock step on that.

But if we're going to have good and effective oversight, it's going to it's going to entail the ability of the oversight Commission to be able to access confidential documents under our subpoena power.

Now the other question that's been raised here is Oh well, goodness, we need to delay everything.

Hold the horses. First of all, we don't have a court decision.

So because maybe the Commission.

Well, let me address that issue. First of all, we've given a lot of thought to the protocols that would be used for, for.

Protecting and maintaining the confidentiality of confidential information that would be provided by the share in the Sheriff's Department under our subpoenas. OK, we've given a lot of thought to this and first of all, I just will say that the standard of security will be the same standard that.

The Sheriff's Department itself.

Public Safety CAR 45 minutes 21 seconds

Uses to protect confidential documents.

Public Safety CAR 45 minutes 23 seconds

That's number one, number two.

Public Safety CAR 45 minutes 26 seconds

Sometime ago, County Council proposed a confidentiality non disclosure agreement with respect to any confidential documents that would be seen or reviewed by any member of the Oversight Commission.

Every member of the Commission agreed to sign that document in order to receive confidential documents.

Public Safety CAR 45 minutes 46 seconds

Every member of the Commission is prepared to sign that document.

Public Safety CAR 45 minutes 50 seconds

We never did it because we've never been able to get confidential documents, but there is a non disclosure confidentiality agreement I'm I'm telling.

Public Safety CAR 45 minutes 57 seconds

I'm telling the Justice Department right now every Commissioner has agreed to sign that document, so that makes them not only contractually obligated not to disclose confidential information, but it also means, by the way, if they do, it's like everybody else.

You're subject to a criminal penalty.

Public Safety CAR 46 minutes 14 seconds

It's a misdemeanor under.

Public Safety CAR 46 minutes 16 seconds

Under the Penal Code, so look.

We wouldn't want review with County Council and make sure that our protocols are adequate.

Obviously this includes. I'm very familiar with, you know, how classified information is handled in the in the federal government.

We're certainly going to be up to the standard of confidential classified information.

I can assure you, which means any hard copy document will be in a lock seal safe and they'll be at appropriate levels of encryptions for any electronic documents.

Let me just address one more thing and that is.

County emails or non county emails?

I can assure you right now the Protocol, the Commission will be that no confidential documents will ever be transmitted by e-mail, whether it's a county e-mail or any other kind of e-mail.

That's our protocol, OK.

Those are our protocols. Not to say we can't reply to more.

We're not going to be.

Public Safety CAR 47 minutes 7 seconds

We're not going to be leaking this information on the undercurrent I I get from this hearing is the reason the real reason and it's not expressed here. But I think the real reason is that somehow I don't know why.

Well, Sheriff alluded to it.

Public Safety CAR 47 minutes 21 seconds

I mean, it's a lack of trust in the Commission right to to be able to handle confidential documents. Well, if we can't handle confidential documents and keep them confidential, don't have a Commission because the Commission can't be effective without having access to confidential documents. That's what the board.

Should do it. Should abolish this Commission because it's ineffective.

It's frustrating for the public, which gave us, gave us a bit of power in the first instance.

I would like to have this process move forward.

We'll get a judicial decision.

We either win it or lose it. By the way, if we lose it, then we know we need legislation.

We know 47.

Maybe maybe there will.

And the legislature is not there.

I don't know, but I this really you know we're we're into the Commission was created and essentially. Well, I was sworn in in December 2016.

It's never been effective because we've never been able to access confidential information.

And the one thing I would really like to discuss is why we need access to confidential information in order to be effective. Because I want to make sure all of you know that and I want to make sure all of your principles know why it is so import.

And I mean, I can illustrate it with a, you know, a hundred example.

I mean, by the way, I'll just use one.

Those are considered confidential under by the Sheriff's Department and by County Council, and they are confidential documents because they identify deputies who are involved in, you know, somebody who died in county jail, right?

So those become personnel records under under state law.

Public Safety CAR 49 minutes

But how can we determine as a oversight Commission?

Public Safety CAR 49 minutes 4 seconds

You know what? If there's any pattern? What are there for people that died that maybe didn't have to die in county jail?

And you might say, well, do you know.

Public Safety CAR 49 minutes 11 seconds

And of course, I'm the chair of the Commission.

And I've been on it three years.

I have no idea.

Public Safety CAR 49 minutes 16 seconds

I have no idea whether there there's something we could do to prevent deaths in county jail. For all I know, everybody, all all 26 people that died last year in county in custody of the Sheriff's Department. For all I know, you know, natural causes.

But we don't know why.

Public Safety CAR 49 minutes 31 seconds

Do you have an oversight Commission?

Public Safety CAR 49 minutes 33 seconds

The ability to be be able to assess that and then sit down with the sheriff, by the way, confidentially.

In private we have.

Public Safety CAR 49 minutes 40 seconds

We have private meetings with the sheriff. Just discuss things.

Public Safety CAR 49 minutes 43 seconds

OK.

Public Safety CAR 49 minutes 44 seconds

Maybe we think there's an improvement that could be made that would prevent that.

Public Safety CAR 49 minutes 48 seconds

We have another.

Public Safety CAR 49 minutes 49 seconds

But where did I that?

Public Safety CAR 49 minutes 51 seconds

Right now we're denied that basic information, but there were 16 headstrikes of inmates in county jails by sheriff deputies.

We don't want to publicize who those deputies are.

Public Safety CAR 50 minutes 3 seconds

We'll never do that.

Public Safety CAR 50 minutes 5 seconds

In fact, I even revised tightened up 03 OK to make sure it's clear we would never do that.

But we do want to be able to look at the, you know, the force reports that were made.

And try to understand why. Why? If it's a violation of policy for the Sheriff's Department ordinarily to engage in head scraggs why were there no discipline behind them?

And there may be very good reasons, but it's an oversight Commission, the public, and I think the board expects us to be able to look at that and say, well, Oh yeah, those are all we understand it. But how can you do that as an oversight Commission unless.

Those are competent.

We make both those requests.

Both were denied by the Sheriff's Department on advice of County Council that would violate state law because the sheriff can't give us that information.

We've asked for the the report on Joseph Perez and the the critical part of the report is redacted based upon confidentiality.

We've subpoenaed that report that's going to be part of the litigation.

That's before the Superior Court anyway.

Public Safety CAR 51 minutes 8 seconds

OK.

Public Safety CAR 51 minutes 9 seconds

I'm in a soliloquy here.

Public Safety CAR 51 minutes 10 seconds

I'm going to stop on the theory that you looked at most of the stuff that I've submitted to the justice deputies and and that the Commission has admitted and just ask you, you know, what your questions are and I'll I'll do my best to answer them.

Sheriff has a question. Just more of a comment and I.

Public Safety CAR 51 minutes 30 seconds

On the example that the I call him, Judge Bonner, because he's always been a judge to me formerly on yes, formal, formally honorable.

Told to me Sir.

Public Safety CAR 51 minutes 41 seconds

Just on the example, just in case you don't know when there's an in custody death in our department, they get extensively reviewed and in the end custody death panel, the inspector general's in there and our federal monitors that are overseeing the settlement agreement.

So again, it goes back to the example of how much oversight layers do we want.

Because if any supervisor had a question.

Public Safety CAR 52 minutes 9 seconds

About what happens in those meetings.

Public Safety CAR 52 minutes 13 seconds

There are federal officials and the Inspector General who sits there and listens and gets everything that we distribute in those reports.

I just I he's making good arguments, but please, I just want the public to know that there is significant oversight that's already taking place by multiple agencies for over the Sheriff's Department, and that doesn't come out enough.

I just wanna clarify that.

Public Safety CAR 52 minutes 40 seconds

Did I say I I totally agree with the sheriff there. There. If you have multiple oversight.

Public Safety CAR 52 minutes 46 seconds

Bodies over one law enforcement agency. That's not good because it allows the oversight bodies the IG can say something fails if a head strikes in the jail.

Something fails people.

Public Safety CAR 53 minutes 1 second

Deputies are reaching for iPhones and and and then taking people to the ground because they didn't give up their iPhone.

Public Safety CAR 53 minutes 8 seconds

If that kind of thing happens, you know you have to have oversight to see what was there, what was investigated, why why wasn't there.

Why didn't it move to discipline and the like?

But I totally agree with the sheriff and the the board said it.

Now it has three oversight bodies over the Sheriff's Department.

There is the civil grand Commission that's been around for 30 years that is limited to the county jails, but that's a big part of the Sheriff's department's operation.

And then you have the IG, so you've set up three, and a sheriff is right.

But that's the same function as the the civilian Oversight Commission has. Why would you even have two commissions that are doing unannounced inspections partic.

Uncoordinated.

Public Safety CAR 54 minutes 42 seconds

And then you have the IG. And by the way, the problem I see it.

You know, I've been around for a long time.

God, I've been, you know, this all started with the before the ccjv, but certainly with the ccjv that I was on.

There's some reasons for that, but the reality is now you have an IG institutionally that really is not the investigative arm of the Oversight Commission, and that's the way it should have been. I I would submit.

Able to be effective in our oversight of the Sheriff's Department and effective means that we actually give the sheriff we we know the situations and we give the sheriff really solid recommendations.

The oversight Commission is not, and it is true by the one more thing, Sheriff, you're absolutely right.

Right. First of all, we can't prevent or will we want to prevent members of the public coming for a public meeting of the Sheriff's Oversight Commission and making a complaint about their treatment by the Sheriff's Department or the fact that their son is no longer alive that act.

That's we do need to hear from the public.

How to change policies and procedures that will address systemic issues within the Sheriff's Department and there are systemic issues within the Sheriff's Department.

And I know the sheriff's trying to address some of them.

We could be more helpful to them if we had access to confidential documents under our subpoena power, OK.

I just want all of you to know that as our department has been.

Progressing forward, we've made some significant improvements on headstrikes.

I'll challenge anybody that the LA County Jail systems, one of the toughest environments to work.

Actually, we've been putting out videos of things that have been going on that we haven't shown before, which I think the public needs to see more of. But I want all of you to know that.

Under one of our settlement agreements with the federal monitors, HEADSTRIKES is specifically something that they're very focused on.

We are very focused on and I'm very happy to say that through some very hard work by our managers and supervisors and deputies, our headstrikes are down over the last year by double digits.

We're just getting better.

Our people are doing a very good job not saying that you know that that the the federal oversight over that should ever go away or go away now. But it's helping us get better in category three use of course really gone down.

And feels, and so let's be commended.

Public Safety CAR 1 hour 20 seconds

But it actually is the roses monitor that is not able to determine why discipline wasn't imposed in any of the 18 head strike cases, or 16. Whatever the number is.

I mean, so they have an issue actually accessing and so we thought it's an oversight Commission. We would probably gain access to it.

We so far we haven't been able to do so.

We're not going to be able to do so until a court tells us we can or the legislature passes 8 ABA 47.

Somebody over here had to come in, but yeah, hesitant to intercede.

And I don't mean to contravene anything the judge or the sheriff has said.

I just for a point of clarification and again not contravening anything that said, but just in light of the audience, to make sure that some of the context and landscape is clear.

There is a lot of material that is already being produced by the Edict of the legislature that does, I think, helps help serve the COC in the OIG and and other oversight agencies that those categories of documents include death review documents.

Shooting that a person that wouldn't be jail contacts, but that would be out in control. Uses of excessive force causing great bodily injury sustained.

Measure E, which imposes a special tax of six cents per square foot of structural improvements on all taxable improved parcels.

Was placed on the November 2024 ballot as a solution to address the district's financial challenges.

The measure was approved by the voters by 55.5% and is expected to generate approximately \$152 million in revenue for fiscal year 2526. The measure E requires an expenditure plan to be approved by the board prior to June.

That's why we're here today and the expenditure plan must include, but not be limited to, the following priorities.

Thumbs, facilities, vehicles and aircraft life saving rescue tools, wildfire protection and emergency response tools.

Infrastructure districts proposed 2526 expenditure plan aligned with these priorities and will include \$62.4 million for facilities.

This includes funding to start the replacement of fire stations 281217 and 22, seismic retrofit of fire stations 37386370 and 78.

A replacement of fire station 81.

In the construction of a new fire station adjacent to fire Station 33, which is our busiest fire station dispatch center.

Expansion to accommodate increasing call volume and some deferred facility maintenance projects that will also include \$17.2 million to be spent on vehicles and apparatus.

This will supplement our annual allocation of 13.9 million to our vehicle accumulated capital outlay fund, which will result in a total of \$31.1 million for vehicle replacement in 2526.

The priorities are to replace emergency vehicles over 20 years of age and to transition non-emergency vehicles to hybrid vehicles. \$3.5 million will be spent to convert 530% engine companies to four person staffing, with the ultimate goal to transition all our 160.
