Title: "Protect Us Like You Protect Others"

Good afternoon,

My name is Raneisha Hubbert. I'm a mother, a taxpayer, and a survivor of your broken system. For the last 11 years, my family has been targeted, torn apart, and traumatized under the custody of DCFS. I am here today because we deserve justice, and we deserve it now.

While you rush to approve emergency aid and protections for immigrant families—and I support their right to be protected—you have ignored your own citizens, like me, who have been screaming for help while being retaliated against by DCFS, social workers, and the dependency court system.

My children were taken. My daughter was raped under your watch. I was never notified. I was never protected. And when I demanded answers, I was met with lies, silence, and false reports. You have seen the emails. You have the proof. And yet—no action. Not one single dollar returned to my family for the trauma we endured.

DCFS lied and claimed I haven't spoken to my daughter. I have videos,

photos, and recordings proving our relationship. I found her when she ran from placement. I made the reports. I did the job her caseworker refused to do.

Now I'm saying enough is enough. I'm not asking—I'm demanding:

Approve my tort claim and issue immediate compensation.

Provide safe housing for me and my children, just like you do for others.

Hold your agencies accountable—no more hiding behind DCFS.

I'm living in fear of DCFS. I can't work. I can't send my kids to school without worrying they'll be taken again. This is not protection—this is state-inflicted harm.

You are breaking federal and state law:

WIC 362.1 - Visitation was never legally denied.

42 U.S.C. § 12132 (ADA) – I am protected under disability law, and you continue to retaliate.

Gov. Code § 11135 – You discriminate while families like mine suffer.

So today, I say to you: Do your job. Protect your own citizens. And stop allowing DCFS to function above the law. This Board is responsible. You have the power to make it right. Don't delay one more day.

Cut the check. Secure our housing. Protect my family.

Hello, My name is Thet Mon Kyaw and I am a volunteer with Project Hepatitis C Connect. I am here today to respectfully urge the Board to expand the Los Angeles County Department of Public Health's Hepatitis C budget by \$441,000 to fund two full-time County-funded staff positions focused on connecting people to cure. Today, more than two out of three Los Angeles County residents with active Hepatitis C remain untreated. That is nearly 17,000 people. Hepatitis C is curable, but if left untreated, it can lead to liver failure, liver cancer, or even death. Just last week, I spoke with a man who had been living with Hepatitis C for years without knowing he was eligible for treatment. He told me he assumed he wasn't "sick enough" to qualify and had

			given up hope. When I explained that the cure is simple, effective, and available, his entire demeanor changed—he was emotional, even hopeful for the first time in a long time.  This was one of the small encounters and there were a lot of similar scenarios that are still ongoing. However, I believe that together we can build a better future. Thank you!

Hello, my name is Daphnee, and I am a USC Keck medical student and also a volunteer caseworker with Project HCV Connect.

I'm writing to urge your continued support in addressing the public health crisis that is hepatitis C. Each year, tens of thousands of people in the U.S. die from hepatitis C—a disease that is fully curable when diagnosed and treated early. These deaths are not due to a lack of medical innovation, but rather to broken systems that fail to educate, link, and support individuals through treatment.

As a Keck USC medical student, I volunteer my time to do this work through Project HCV Connect. Despite the dedication of our volunteer team, we are still trying to reach people who tested positive more than a year ago. We simply do not have the staffing or infrastructure to provide timely follow-up and connection to care. We need full-time, paid case managers and a system that can proactively track and support patients through treatment.

One patient I spoke to had lived with hepatitis C for so long that by the time I reached him, he had told me he was diagnosed with stage IV liver cancer, which is terminal. This is completely preventable and we should be making a stronger effort to reach people.

That is why I strongly support the motion passed in June 2024 directing the Department of Public Health and the Chief Executive Office to assess the feasibility of expanding hepatitis C care coordination by adding 2 full-time paid staff members within the department of public health to focus on Hepatitis C linkage-to-cure. I also urge broader support for expanded treatment assistance and care resources for all residents living with hepatitis C in LA County.

We have the tools to cure hepatitis C. Now we need the systems and staff to make that cure accessible to all.

# Don't Let Progress Stall: Fund Hepatitis C Care in LA County Support 2 Full-Time Department of Public Health Positions

### Why Hepatitis C Is a Public Health Issue

- → 2 out of 3 LA County residents with active hepatitis C remain untreated
  - → That's nearly **17,000** untreated people in LA County!
- → <u>Hepatitis C is curable</u>, but if untreated, it can lead to liver failure, liver cancer, or death
- → LA County's current cure rate is only 32%, well below the federal 2025 goal of 58%
- → Untreated people can transmit HepC to others, including family & emergency responders
  - → That's why it's a <u>public health issue</u>: counties may not provide direct medical care, but they are responsible for preventing disease transmission

## Why County Funding Is Critical

- Many affected people face serious barriers to care: unstable housing or substance use
- LA County's current hepatitis C response relies on <u>CDC grants expiring in mid-2026</u>
- Without County-funded staff, Hepatitis C elimination will not be possible!

#### Our Ask to the Board:

We respectfully request that the Board of Supervisors expand the LA County Department of Public Health budget by \$441,000 to fund 2 full-time, County-funded staff dedicated to:

- > Proactive outreach to untreated individuals
- > Building partnerships with providers, clinics, and pharmacies
- > Coordinating care for vulnerable populations
- > Ensuring long-term sustainability for hepatitis C elimination efforts

Good Morning, Supervisors,

My name is Kahlila Williams. I am a Youth/Alumni organizer with Students Deserve. I'm speaking today to urge you not to move the girls and gender-inclusive youth to Malibu. Free the 50 now.

As a young person who has organized for years alongside students impacted by policing, incarceration, and systemic neglect, I've seen firsthand what our communities need, and it's not more cages. It's not another locked facility far from home. What they need is a caer, investment, and freedom.

The youth currently at Los Padrinos deserve so much more than a new site of confinement. They don't deserve to be retraumatized by being transferred to another harmful location in Malibu. Let's not forget that Probation is under a \$4 billion settlement for child sexual abuse in its own facilities. Why should we trust that system to care for these youth?

What we can trust is our community! These are alternatives now, Beloved, rapid release pathways and placement options grounded in healing and accountability. These programs are already working.

So I'm asking you, as someone who grew up in this system, who organizes with youth still in it, to do what you promised. Stand on your commitment to end incarceration for girls and gender expansive youth. Reject the transfer. Invest in freedom. Free the 50. Thank you.

Altadena Community Restorative Investment (ACRI)

A One-Billion Dollar, Three-Phase, Ten-Year Spending Plan from Measure J Direct Community Investment Funds

The Altadena Community Restorative Investment (ACRI) represents a historic and transformative opportunity to rebuild and reimagine the future of Altadena. Designed as a bold and strategic plan, ACRI proposes a ten-year, \$1 billion investment delivered in three phases utilizing unspent Measure J funds allocated for direct community investments.

This initiative comes at a critical time in Altadena's history. In 2025, the region endured the devastating Eaton Fires, the most destructive wildfire in Los Angeles County's history and the fifth deadliest in California. The fire claimed at least 17 lives, destroyed over 9,400 structures—including homes, schools, houses of worship, and small businesses—and displaced thousands.

Altadena holds deep cultural and historical significance, especially for its Black residents. Since the 1960s, it has served as a rare place where Black families could purchase homes and build generational wealth. However, rising housing costs and structural inequities have placed a disproportionate burden on Black homeowners, many of whom now face displacement or lack the means to pass down property to the next generation.

In this moment of both recovery and opportunity, ACRI seeks to advance the core mission of Measure J—by providing direct, restorative investment to the community, particularly those most impacted by the wildfires and systemic disparities.

# Purpose and Urgency

For years, budget cuts from Sacramento and economic downturns have strained Los Angeles County's ability to provide essential services. Measure J created a sustainable local funding source protected from state reallocation to support community-based programs and alternatives to incarceration.

While the County Board of Supervisors approved \$324 million in Measure J funding for direct community investment, full-scale disbursement has yet to occur. These funds, along with future allocations, remain available and should be urgently deployed to meet Altadena's critical needs.

ACRI Ten-Year Spending Framework

Total Investment: \$1 Billion

Three Installments Over Ten Years:

Phase 1: \$324 million (2025–2027)

Phase 2: \$336 million (2028–2030)

Phase 3: \$340 million (2031–2035)

Phase 1 Allocation Overview (2025–2027)

\$55 million – Affordable and permanent supportive housing for the County's most vulnerable populations

\$15 million – Small business development, including recovery grants for fire-affected businesses

\$10 million – Youth development and educational programs

\$10 million – Workforce education and job training

\$8 million – Rental assistance and housing support services

\$10 million – Third-party administered community grants to be distributed to grassroots, community-based organizations

County departments are encouraged to prioritize direct funding to community providers, ensuring equitable access and community-driven solutions.

Looking Ahead

The ACRI plan is a bold, long-term commitment to justice, equity, and healing for Altadena. It is not only an investment in recovery, but also an investment in the future.
