So this bill, authored by Supervisor Solis co-authored by Supervisor Forbath, would support AB 695 by Assembly member Mike Fong and the bill's intention is to support students who are currently enrolled in Community College throughout the state of California. If they are deported to be.

Able to continue their education to whatever country they have been deported to. Remotely and still do it have getting in state tuition.

Right. So generally speaking, obviously you have to live in state in order to receive this benefit. However, as we know, given deportations that are happening across the country and certainly here in California, some students have are being deported. And of course we would love to support them to.

Able to make sure that they can finish their education that they had already started here.

In California, so the bill would allow for that.

Allow them to have in state tuition as long as they're obviously enrolled in online learning at the Community College system. And it would also allow that if they are able to make their way back to the country someday, that they can also receive in state tuition to contin.

Their education and then I can guesty too, asked about general fund costs. It looks like it's a general fund cost of 25 to 65 K.

Already committed.

And I think I also mentioned that this was.

Just recently passed the Assembly, so it's heading to the Senate floor.

There's not opposition on file and a majority of the support is coming from education groups.

They're saying if you want a letter, just make it clear so it'll it will just say support this motion and also send a letter to assembly Member Mike Fong and the LA County delegation demonstrating the county support.

That'll that'll come in when it's obviously posted on the agenda.
