		Other	Bianca R Stopani	Good evening, Los Angeles County Board of Supervisors. My name is Bianca, and I'm here today to address the critical issue of police brutality by the Los Angeles County Sheriff's Department against peaceful protesters. These individuals are exercising their First Amendment right to freedom of speech, and it's unacceptable that they are met with aggression and violence. I witnessed firsthand an incident just two days ago near Union Station, before curfew. As I was heading to the station, I saw three LASD deputies taking pictures on their phones in an unmarked area. When we approached, a deputy appeared to be under the influence of a substance and aggressively confronted us, despite our simply asking for directions to Union Station. I have video evidence of this encounter. Furthermore, there are serious concerns about the misappropriation of funds within the LASD. Funds allocated for improving conditions in our jails are instead being used for better guns and vehicles, while inmates suffer from inadequate linen, hygiene, food, medical treatment, and mental health care. The food provided is often limited to bologna and peanut butter and jelly sandwiches, without juice or balanced nutrition. I urge the board to hold the LASD accountable for these abuses of power and to ensure that funds are used appropriately to support the well-being of those in our jails. Thank you.

Public Comment		Other	Elizabeth C Zuniga	Hi, my name is Elizabeth Zuniga, and I am a volunteer caseworker for Project HepC Connect. Today, I am here to ask the Board to expand the LA County Department of Public Health's Hepatitis C budget by \$441,000 to fund 2 full-time staff positions focused on linkage-to-cure. Right now, more than two-thirds of people in LA County with active Hepatitis C, which is about 17,000 people, aren't receiving treatment, even though this disease is curable. That's a huge number, and it represents a major gap in care. Without treatment, people are at serious risk of liver failure, cancer, and other life-threatening complications. But beyond that, untreated Hep C also puts others at risk, especially family members and first responders who may not even know they're being exposed. This is clearly a public health issue, not just a personal one. The County's current cure rate is only 32%, which is well below the national target of 58% by 2025. And most of the work being done now depends on federal grants that are set to expire in 2026. Without dedicated County funding, we're at risk of losing momentum and the infrastructure we need to actually eliminate Hep C in LA County. The additional staff would focus on reaching out to people who haven't been treated, helping them navigate care, and working with clinics, providers, and pharmacies to strengthen the system overall. Cities like Norwalk, Pico Rivera, Paramount, Beverly Hills, and West Hollywood have already shown their support. This is a smart, targeted investment in public health and one that could truly save lives. Thank you for your time.

Attractants: The growth of the homeless population and improper disposal of food and waste has attracted coyotes and contributed to their proliferation in urban areas.

City's Responsibility: Citizens pay taxes for the city to maintain safety and order, and it should be the city's responsibility to manage the costs and logistics of mitigating the coyote issue, as other cities like Torrance have successfully done.

Lack of Action by City Agencies: There seems to be a lack of clear responsibility and action by the city's Animal Services and California Fish and Wildlife in managing and controlling the coyote population.

Legal Limitations on Protective Measures: The current laws limit the height of fences to 6 feet, a height easily cleared by coyotes, thus compromising the safety of homes and properties.

Health Concerns: Coyotes carry a range of diseases and parasites, creating an additional health hazard for the city's residents.

Financial Consequences: Coyote attacks can cause serious injuries to pets, resulting in costly veterinary bills, and the city has so far not provided financial assistance for these damages.

Coyotes in Urban Spaces: Coyotes are frequently sighted in urban spaces, including parks, where children and pets are commonly present.

Lack of Monitoring: There's a lack of adequate monitoring and reporting of coyote attacks by city authorities.

Don't Let Progress Stall: Fund Hepatitis C Care in LA County Support 2 Full-Time Department of Public Health Positions

Why Hepatitis C Is a Public Health Issue

- → 2 out of 3 LA County residents with active hepatitis C remain untreated
 - → That's nearly **17,000** untreated people in LA County!
- → <u>Hepatitis C is curable</u>, but if untreated, it can lead to liver failure, liver cancer, or death
- → LA County's current cure rate is only 32%, well below the federal 2025 goal of 58%
- → Untreated people can transmit HepC to others, including family & emergency responders
 - → That's why it's a <u>public health issue</u>: counties may not provide direct medical care, but they are responsible for preventing disease transmission

Why County Funding Is Critical

- Many affected people face serious barriers to care: unstable housing or substance use
- LA County's current hepatitis C response relies on <u>CDC grants expiring in mid-2026</u>
- Without County-funded staff, Hepatitis C elimination will not be possible!

Our Ask to the Board:

We respectfully request that the Board of Supervisors expand the LA County Department of Public Health budget by \$441,000 to fund 2 full-time, County-funded staff dedicated to:

- > Proactive outreach to untreated individuals
- > Building partnerships with providers, clinics, and pharmacies
- > Coordinating care for vulnerable populations
- > Ensuring long-term sustainability for hepatitis C elimination efforts
