Dear members of the Board of Supervisors Public Safety Cluster,

As the Councilmember for Los Angeles City Council District 1, I am writing regarding the Chief Executive Officer (CEO) recommendations for the Year Four Care First Community Investment (CFCI) Ongoing and On-Time Spending Plan. I would like to express my support for two specific proposed programs:

- Department of Health Services | ODR-Harm Reduction Division: The MacArthur Park Overdose Response Team
- The Department of Public Health | Trans, Gender Expansive, and Intersex (TGI) Wellness and Equity Initiative

Since launching in late 2024, members of the MacArthur Park Overdose Response Team have saved the lives of over 70 people through overdose reversals and positively impacted countless more. In addition to overdose reversals, the team has distributed over 15,000 doses of naloxone, hundreds of hygiene kits and collected over 16,000 biohazardous materials such as sharps and pipes. Within just a few months of their one-time funded program, the team has become absolutely critical to the City and County's response to the public health crisis in and around MacArthur Park, the epicenter of the opioid crisis in Los Angeles. It is imperative that these services are funded long-term.

Los Angeles City Hall 200 N. Spring Street, Room 460, Los Angeles, CA 90012 Especially in light of the attacks on the rights of Trans, Gender-Expansive, and Interssex (TGI) populations, it is more important than ever to address the systematic barriers faced by TGI communities I fully support the proposed \$7 million, two-year investment in the TGI Wellness and Equity Initiative, which will go toward TGI-led organizations that deliver essential health, housing, and community services across the County.

Both of these programs speak directly to the vision and goals of a "Care First" approach in LA County, and through direct community investments they will move toward the creation of a more just and equitable Los Angeles County. I urge you to support them.

## Subject: Ensuring Alignment and Integrity in FY 2025–26 CFCI Unspent Funding Allocations

Supervisors,

I first would like to acknowledge the Board's continued leadership and foresight in this deeply challenging fiscal climate. Even in one of the most difficult budget years in Los Angeles County's history, your commitment to the Care First agenda stands as a bold affirmation of the values we are collectively advancing. Your decision to center equity, healing, and accountability through public motion and through resource allocation is not only being watched across the County, but studied by governments and communities across the nation and globe. What we are building here together is nothing short of a new model for public safety, public health, and community power.

In a time when police militarization is escalating and repressive federal actions are rising against so many of our neighbors and community members, Los Angeles County should continue to chart another path. It is important that this path is one where communities most impacted by systems of harm are also the architects of their own wellbeing. This is the future our people want to see: a future that is co-governed, community-informed, and rooted in care. That vision requires clarity, transparency, and trust in the process. The commitment to that process is more than procedural. It's a statement of belief in the possibility of a care first, jails last world.

I write to you in my capacity as Chair of the Care First Community Investment (CFCI) Advisory Committee to affirm our commitment to the funding allocation process outlined in your unanimously adopted motion on May 6, 2024: "Ensuring Transparency and Accountability of Care First Funding." Through that motion, the Board's intent that all future recommendations regarding the allocation or reallocation of unspent CFCI funds align with the priorities established by the CFCI Advisory Committee, especially those that are fundamentally direct community investments and alternatives to incarceration.

At our June 12, 2025 meeting, the Advisory Committee finalized a community-driven process that will deliver a comprehensive set of FY 2025–26 funding recommendations to the Board by July 31, 2025, in time for consideration during the Supplemental Budget phase. That process includes:

- A Concept Recommendation Form that will be used uniformly by community-based organizations, County departments, the CEO's office, and the Third-Party Administrator. This will ensure all proposals—regardless of source—can be assessed equitably and transparently.
- A public **submission period from June 23 to July 7, 2025**, during which concept recommendations will be collected alongside a **Countywide Community Survey** to surface updated public priorities. The last survey was conducted in 2023, and the current community context demands a fresh perspective.
- A **period from July 7 to July 31** during which the Committee will review and deliberate on all submitted proposals, ensuring that recommended projects align with CFCI's core goals and are viable for implementation in this fiscal year. Selected recommendations will then be sent to the Board of Supervisors for further consideration.

We are excited to complete this process. However, we recently became aware of a board letter from the CEO's Office scheduled for your June 25, 2025 agenda, which proposes to reallocate portions of the unspent CFCI balance. While we recognize that some of the projects outlined in that letter may reflect important priorities, these proposals are not vetted and prioritized recommendations from the Advisory Committee through our public process.

As such, we respectfully urge the Board to **NOT approve of the CEO's current recommendations** and instead allow the CFCI Advisory Committee to complete its public, equitable, and community-informed process. All proposals, including those from the CEO's office, will be considered on equal footing as part of our formal review. Advancing isolated funding recommendations outside of this process outlined above would undercut the collaborative, community-first approach that CFCI was designed to uphold.

We remain committed to delivering thoughtful, timely, and actionable recommendations by **July 31, 2025**, and we thank you for your continued partnership as we work to build a more just, more humane, and more care-centered Los Angeles County—by community, for community.
