42 U.S.C. § 1983 – My civil rights were violated under color of law

ADA Title II – 42 U.S.C. § 12132 – You denied me access and accommodations while I was traumatized

California Civil Code § 52(b) – Allows actual and punitive damages for civil rights abuse

CA Govt Code § 825.6 – The County is liable for torts committed by its agents

Welfare & Institutions Code § 361.2(b)(1) – My parental rights were bypassed illegally
