Oppose	paul C burt	- I oppose the Los Angeles County Board of Supervisors' endorsement of Assembly Bill 1127 (AB1127) as it blatantly misplaces focus on restricting lawful firearm sales rather than addressing the root causes of gun violence through enforcement of existing laws. The bill targets semi-automatic pistols, like Glocks, that can be converted into automatic weapons using illegal "Glock switches," citing incidents like the April 3, 2022, Sacramento mass shooting that killed six and injured twelve. Court records and news reports confirm that the perpetrators in that tragedy - D'Andre Martin, Smiley Martin, and Mtula Payton - were repeat, violent felons with extensive firearm-involved convictions. D'Andre Martin had prior convictions for illegal firearm possession and domestic violence, to name but 2. At the time of the shooting, Smiley Martin was on parole for firearm and assault charges, and Mtula Payton had a history of violent offenses, yet all were released early under California's lenient sentencing protocols, including Proposition 47 and 57, which reduced penalties and enabled early parole for violent, repeat offenders such as these people. DA Nathan Hochman has emphasized that existing statutes, such as Penal Code 12022.5 (firearm use enhancements), already provide for severe penalties - up to seven years per offense - but are underutilized due to prosecutorial discretion and egregiously irresponsible early release policies. The Sacramento shooting, involving a converted Glock, underscores that the issue lies not in the availability of legal firearms but in the failure to keep repeat offenders off the streets. AB 1127 burdens law-abiding citizens and dealers, as noted by the California Rifle and Pistol Association, while ignoring the criminal justice system's flaws that allowed these felons to act AGAIN! Instead of endorsing restrictive new laws, the Board should support Hochman's push for stricter enforcement of current statutes to prevent such tragedies.

AB-1127 is a farce—a diluted, feel-good attempt to reduce gun violence that comes at the direct expense of responsible gun owners. It punishes the 99% of Glock owners who follow the law because of the actions of a tiny criminal minority. FBI data shows that the overwhelming majority of handguns used in crimes are obtained illegally, which means this bill will do nothing to stop criminals. Instead, it strips law-abiding citizens of access to one of the most trusted and reliable tools for self-defense.

This is nothing more than a cheap political ploy, preying on the fears of families who simply want to feel safe, while offering no real solution to the violence in our communities. Politicians are selling the illusion of safety, knowing full well that criminals will ignore this law just as they ignore the ones already on the books.

The Second Amendment guarantees our right to choose effective firearms for self-protection. If lawmakers can casually erode this right under the guise of safety, what assurance do we have that they will protect our other constitutional rights when they become politically inconvenient? A government that can pick and choose which rights to respect is a government that can take them all.

AB-1127 does not make California safer—it simply shifts power away from responsible citizens and into the hands of criminals. We should be demanding that our leaders enforce existing laws, target illegal trafficking, and hold violent offenders accountable, not undermine the rights and security of the very people they are sworn to protect.
