Favor	Carlos M Montes	My concerns with the Extera school project have not changed since last October 2024 when the item was before the Board We support the Board action back in October 2024 that moved to deny the CUP for Extera.  Urge the entire Board of Supervisors to support the denial of the CUP for the Extera Charter School  ELA is a very impacted community with a long history suffering from many social, economic, environmental and traffic burdens.  The location for the proposed school is not compatible, it is in an area which is dense in the middle of single and multi-family residential uses next to the 5 freeway.  Concerns with bringing concentrated trips to one area from the 3 proposed schools (300 plus students) to be relocated and consolidated at the subject site and magnified with an additional capacity for up to 525 students total if approved.  Traffic congestion, pedestrian safety (with double parking and with the pedestrian bridge at Dennison St), environmental impacts with idling cars adding to being adjacent to the 5 fwy, blocking of private-driveways.  Dennison Street is used as a fast thorough fare to cut through very impacted ELA residential streets.  With the traffic congestion, double parking and blocking of private driveways, there's also concerns that fire and emergency response units could not get through therefore impacting the life of those needing the emergency services. There's a lack of confidence that, in practice, the recommended conditions in the approval and any other conditions would be carried out and effective to mitigate the concerns and impacts.
