Agenda # Public Comment	Relate To	Position Other	Name Ann Dorsey	The County's commitment to upholding the will of the voters must be made apparent by taking steps to enact the tennats of Measure J - to shift public dollars away from incarceration and into life-affirming investments like youth development, mental health care, reentry support, housing, and economic opportunity for historically marginalized communities.  I urge you to take the following steps to correct the ommission of Measure J from the updated County Charter:  *Refine Directive 5 so that it explicitly explores a Charter Amendment to fix or remove the harmful provision in Measure G, which repealed Measure J. A direct reversal or cleanup of the repealing language in Measure G would offer a cleaner legal path and preserve the original intent of the voters. Also, County Counsel's review would benefit from direction that focuses on restoring J via repeal of G's conflicting provision, instead of framing it as a new voter choice on J.  *Commit to looking in to placing Measure G back on the ballot in 2026 with amendments to affirm Measure J and restore its full legal authority and explicitly incorporate it into the new governance structure.  *Fix the structural oversight by ensuring future charter amendments undergo
				a comprehensive legal compatibility review before being brought to voters.  *Ensure the monitary commitment to this measure does not expire in December 2028. As it stands, the economic fallout of this error risks the long-term stability of community investments, threatens job creation, and undermines racial justice work already in motion.  *Call in poor policy-making practices by establishing a transparent, community-informed process to prevent similar governance failures in the future. Public Comment		Other	Cassidy Hernandez- Tamayo	Good morning, my name is Cassidy Hernandez-Tamayo and I am a volunteer with Project Hepatitis C Connect. I am here today to respectfully urge the Board to expand the Los Angeles County Department of Public Health's Hepatitis C budget by \$441,000 to fund two full-time County-funded staff positions focused on connecting people to cure. Today, more than two out of three Los Angeles County residents with active Hepatitis C remain untreated. That is nearly 17,000 people. Hepatitis C is curable, but if left untreated, it can lead to liver failure, liver cancer, or even death. Right now, our cure rate is only 32 percent, which falls well below the federal goal of 58 percent by 2025. This is not just a medical issue. It is a public health issue. People who are untreated can unknowingly transmit the virus to family members, first responders, and others. Counties are responsible for preventing disease transmission, and we must act now. Many of the people affected face serious barriers to care like unstable housing or substance use. Los Angeles County Department of Public Health's current Hepatitis C efforts rely heavily on CDC grants that are set to expire in 2026. Without County-funded staff, we will not be able to sustain or expand elimination efforts. We have the cure. Now we need the staff to deliver it. Thank you.

Today, I am here to urge the Board to move forward with a supplemental budget request to expand the LA County Department of Public Health's Hepatitis C budget by \$441,000 to fund 2 full-time staff positions focused on linkage-to-cure.  Presently, 2 out of 3 LA County residents with active Hepatitis C remain untreated even though treatment to cure exists. If left untreated by medication, individuals may develop liver disease, cirrhosis, and even liver cancer. Hepatitis C is not only a personal health issue, but it is also a public health concern. People living with Hep C can unknowingly transmit the virus to others, including family members, partners, and emergency responders.  Many individuals I have worked with have had no idea they were positive for Hepatitis C, for how long they have had it, and are scared by the complications they may develop. Most are more than willing, proactive, and grateful for the linkage-to-cure assistance our program provides, but our
				volunteer program cannot do it alone.  The Board must act immediately by requesting a supplemental budget to fund two full-time staff to focus on linkage to cure. Together, we can build community coalitions, save lives, and combat this pressing public health issue in our LA County.

Despite state "**hold harmless**" funding after the Eaton Fire, PUSD is reassigning our 4th/5th grade French DLIP English teacher, directly impacting three classrooms that were already the most affected by the fire. This decision not only adds trauma for children still in recovery, but also threatens their already compromised academic stability.

Reassignment undermines the funding safeguard's purpose, worsens class sizes, destabilizes a fragile immersion program, and risks further enrollment loss.

We respectfully ask that Altadena Arts Magnet students be fully protected under "hold harmless" status so they receive stability in practice, not just in policy.
