The Los Angeles County Aging & Disabilities Department (AD) seeks approval and delegated authority to accept and allocate an awarded amount of \$100,000, and any additional grant funding augmentation from the California Department of Aging (CDA) under the Los Angeles Wildfire Relief Grant (contract number WF-2425-19). Approval is also requested for an appropriation adjustment. These funds will be used to provide case management services, including purchase of necessary services during the care management process, to assist with recovery and stabilization following the January wildfire disaster.

#### IT IS RECOMMENDED THAT YOUR BOARD

- 1. Approve and authorize AD's Director or designee to accept and execute the Los Angeles Wildfire Relief grant award in the amount of \$100,000 and any subsequent funding, should any become available under contract number WF-2425-19.
- 2. Approve and authorize AD's Director, or designee, to execute amendment(s) to extend the term of the Contract, if one is offered by CDA before expiration.
- 3. Approve the attached appropriation adjustment necessary to accept the State funding (Attachment I), increasing AD's

operating budget by \$100,000, fully offset by Los Angeles Wildfire Relief Grant funds.

#### PURPOSE/JUSTIFICATION OF RECOMMENDED ACTION(S)

AD, through existing case management programs, will assess the needs of older adults and people with disabilities, 60 years and older, who seek assistance in and around the impacted fire areas for disaster recovery and stabilization.

The recommended actions are necessary for AD to accept the Los Angeles Wildfire Relief grant from the CDA. Funding is necessary in order to conduct in-depth assessments and identify unmet needs of older and disabled adults 60 years and older impacted by the January 2025 Eaton and Palisades Wildfires, to enable them to live safely in the community during post-disaster recovery. Through its existing case management infrastructure AD will leverage this funding to:

- Deliver targeted, client-centered interventions for recovery and stabilization.
- Purchase essential services such as caregiver support, replacement of durable medical equipment, temporary housing, and other necessary goods or services identified during care planning; and
- Coordinate with other local relief and recovery systems to avoid duplication and maximize impact.

This support is especially important for older adults and people with disabilities who are 60 years and older, who often face risks during and after disasters and require tailored support to achieve long-term recovery. Accepting this funding affirms the County's commitment to recovery and helps ensure that impacted residents can regain stability, safety, and dignity in the wake of disaster.

#### IMPLEMENTATION OF STRATEGIC PLAN

The recommended actions support the following Countywide Strategic Plan Goals:

- North Star 1, Focus Area Goal D, Strategy 7 (Older Adults & People with Disabilities) by supporting purposeful aging, enhancing service delivery and care, promoting accessibility, and championing an environment where the needs, health, well-being, and rights of older adults, people with disabilities, and those who are dependent are prioritized.
- North Star 2, Focus Area Goal E, Strategy 4 (Disadvantaged Communities)
   Invest in and strengthen the economic capacity and infrastructure in historically disadvantaged and under-resourced communities.
- North Star 3, Focus Area Goal G, Strategy 1 (Maximize Revenue) Implement processes to systematically leverage resources to help fund county resources.

### **FISCAL IMPACT/FINANCING**

Funding for the Los Angeles Wildfire Relief is \$100,000 and, upon approval from CDA, will be included in AD's Fiscal Year 2025-26 operating budget, through an appropriation adjustment, increasing AD's operating budget by \$100,000, fully offset by Los Angeles Wildfire Relief Grant funds. Approval of the appropriation adjustment is also requested. The requested Board authority will enable AD to allocate these funds to designated Case Management Contractors servicing the wildfire affected areas through March 2026. There is no net County cost associated with this program.

#### FACTS AND PROVISIONS/LEGAL REQUIREMENTS

CDA allocates funding to the County for the administration of programs serving older adults and people with disabilities. As the designated Area Agency on Aging (AAA) for the County, AD is requesting delegated authority to accept grant funds for the administration of wildfire relief efforts to service older adults and people with disabilities who are age 60 years and older impacted by the wildfires and to execute the associated contract and any subsequent amendments.

### **CONTRACTING PROCESS**

As the designated AAA, AD provides case management services to older adults throughout Los Angeles County, excluding the City of Los Angeles. AD administers these services through its network of contracted service providers which deliver case management and supportive services to older adults and individuals with disabilities across the County. Each of these programs includes case management services that were secured through open, competitive bidding from qualified agencies and awarded based on final approval by the Board of Supervisors.

#### **MONITORING REQUIREMENTS**

Administrative, programmatic, and fiscal monitoring of the Subrecipients will be conducted on an annual basis to ensure compliance. Administrative and programmatic monitoring are completed by AD's Compliance Division. Fiscal monitoring is conducted by an approved vendor procured through the Los Angeles County Master Agreement for As-Needed Contract Audits/Studies.

#### **IMPACT ON CURRENT SERVICES**

Approval of the recommended action will enable an increase and enhance its current case management services by providing additional, flexible resources specifically

designated for disaster recovery and stabilization efforts to clients affected by the January 2025 Los Angeles Wildfires. These services will offer essential resources and support to promote their health, dignity, and independence. Such services include, but are not limited to caregiver services, temporary rental assistance, fire debris clean-up or home modification to restore habitability, replacement of household items and medical equipment.

#### **CONCLUSION**

Upon your approval of the recommended actions, AD's Director, or designee, will proceed to execute contract number WF-2425-19 with CDA, and any future amendments as noted herein.
