Program (ERRP) and to offer some suggestions for its successful implementation.

I commend Supervisor Horvath and the Board for proposing this revised motion to implement the ERRP. The wildfires in January 2025 were devastating, and the Board's initial actions to provide emergency eviction protection were a necessary response. As the documents note, those temporary protections expired on July 30, 2025, and there is still an ongoing need for relief.

The proposal to create three priority groups for the program is a thoughtful approach to addressing the diverse needs of our community. I particularly appreciate the following aspects of the motion:

Support for Wildfire-Impacted Households: The program rightly prioritizes tenants who have been directly impacted by the wildfires and lost income, and it includes those who may not have been able to provide self-certification forms. It also extends assistance to displaced households who have exhausted other forms of aid from FEMA or insurance, as well as small landlords needing mortgage relief to repair their units. This shows an understanding that the effects of the wildfires are long-lasting and require ongoing support.

Addressing Broader Economic Hardships: I strongly support the establishment of Priority Group 3, which recognizes the impact of "volatile federal actions" and other economic hardships, such as sudden income loss due to aggressive immigration enforcement. This demonstrates the County's commitment to protecting all vulnerable Angelenos from housing instability, regardless of the cause of their hardship. The allocation of \$5 million in initial funding to this group is a crucial step.

Creating a Flexible Framework: The motion's directive to the Department of Consumer and Business Affairs (DCBA) to create an ongoing, flexible framework for future emergencies is forward-thinking and essential. This will allow the county to respond more quickly to new challenges as they arise, preventing future housing crises.

However, to ensure the program's success, I urge the Board to consider the following:

Public Outreach and Accessibility: The motion notes that demand for the initial rent relief was lower than anticipated, potentially due to the limited number of form downloads. I urge the DCBA to launch a robust, multilingual outreach campaign to ensure that all eligible residents are aware of the program and how to apply. This is especially critical for Priority Group 3, given the fear that may be present in immigrant communities.

Rising insurance premiums, increasing maintenance and operating costs, and strict rent control regulations leave very little margin to sustain our properties.</p> <p>Contrary to the perception that landlords are large corporations, more than 80% of housing providers in Los Angeles are “mom-and-pop” owners. We rely on timely rent payments to cover mortgages, property taxes, and upkeep. Additional restrictions or unfunded mandates only push small owners closer to financial hardship, ultimately reducing the availability and quality of housing in our city.</p> <p>If the City wishes to prevent evictions and homelessness, the solution should not come at the expense of small property owners who are already stretched thin. A sustainable policy would involve direct assistance from federal, state, or city funds to tenants in need, rather than shifting the entire burden onto housing providers. Without this balance, the long-term result will be fewer affordable rentals and a worsening housing crisis.</p>

Members of the Los Angeles County Board of Supervisors:

On behalf of the California Business Roundtable Board of Directors, I am writing to respectfully express opposition to the proposal on today's agenda that would extend eviction protections for tenants impacted by Immigration and Customs Enforcement (ICE) raids.

Housing policy works best when it is clear, enforceable, and consistent. Adding new, event-specific categories of eviction protection—no matter how sympathetic the underlying situation—complicates an already complex system and invites uneven enforcement.

This proposal would also shift responsibilities onto landlords who have no role in federal immigration enforcement, effectively requiring them to navigate circumstances they cannot control and for which there is no clear process. Property owners already face challenges with overlapping state and local tenant protections, and layering on new, narrowly tailored rules increases confusion, legal liability, and financial strain.

We urge the Board to consider alternative approaches that support vulnerable residents without destabilizing housing policy or imposing additional burdens on small and large housing providers.

We respectfully ask the Board to reject the proposed extension of eviction protections and instead focus on holistic solutions that both protect tenants and maintain a fair, workable housing framework.
