Turning publicly owned flood-control and utility corridors into shaded, nature-rich, car-free connections is how we deliver equity, safety, climate resilience, and health to communities that have waited the longest. We appreciate the motion's clarity in: Establishing Urban Natureways as a formal park classification in the General Plan, Adopting the Compton Creek, Emerald Necklace, Lower LA River, and Pacoima Wash into the Regional Trail Network, Designating Department of Parks and Recreation as lead with Department of Public Works permit streamlining and a pre-approved improvements list, Launching an Urban Natureway Marketplace for small businesses and workforce pipelines through local Conservation Corps, and Creating an interagency working group and a funding strategy that leverages Prop 4 and other sources. To ensure these benefits reach the families who live along these corridors today, I respectfully request three amendments: Anti-displacement guardrails with metrics. Direct DPR/DEO to publish an Urban Natureways Anti-Displacement Toolkit within 120 days and require its use in High-Need PNA+ areas, with a funding target of at least 70% of Natureways dollars to disadvantaged communities. Publish a Design & Operations Manual within 180 days that embeds flood, MS4 water-quality, ADA, lighting/under crossing safety, habitat standards, and 5-year O&M plans tied to a dedicated Natureways maintenance fund. Jobs you can raise a family on. Set local-hire and paid apprenticeship goals via Conservation Corps, Youth Works or similar type program and track job placements publicly. Last, please clarify the numbering and consolidate the LAIR directive so departments have clear direction on what's adopted. With these refinements, Urban Natureways can be a national model for equity-centered green infrastructure. Thank you for your leadership and I am positive that the communities of the East Sa

Convergence Note (Jan. 21 IPM → Civil Service Reform Hearings)

The January 21, 2025 Interactive Process Meeting documented my assignment to clerical-only duties by a CMMD supervisor who sought to remove "clinical" from my psychologist role, in direct contradiction to my state-issued license and mandated reporter obligations. I specifically raised vacancy misuse, suppression of postvention duties following a suicide, and the systemic risks of restricting licensed clinicians to clerical functions.

Eight months later, these same themes were publicly acknowledged at the September 10 Health & Mental Health Cluster and September 23 Board hearing on AB 2561 implementation:

- **CEO Joseph Nicchita** described civil service rules as "20–30 years out of date," stressing the need for innovation and efficiency under AB 2561 reforms.
- **DHR Director Lisa Garrett** confirmed employees are "stuck in clerical" and outlined plans for mobility pathways and a skills database.
- Supervisors Solis and Hahn highlighted vacancy misuse, pipeline gaps, and the need to link workforce practices to public outcomes.

This convergence establishes that the systemic barriers I identified at my Jan. 21 IPM are now a matter of public record. The Board's own leaders and executives have validated the substance of my disclosures, even as the Department has withheld my IPM documentation, performance evaluations, and ADA accommodations. The September 10 and 23, 2025 hearings therefore function as surrogate IPM records and must be preserved in full.

Good morning, Chair Barger and Honorable Supervisors,

I write regarding the September 30, 2025 agenda. Multiple items (8, 14, 16, 21, and 48) reflect direct structural and narrative convergence with the BureauCare-to-Custody-Cemetery PipelineTM (BCCPTM) and B2C3ATM Pipeline Prevention Model, both of which I authored and formally entered into the Los Angeles County public record on April 10, 2025 (U.S. Copyright TXu 2-486-534).

These frameworks were formally introduced through my publication, *Introducing the BureauCare-to-Custody-Cemetery Pipeline*TM (BCCPTM): A Public Health Framework for Systems Equity, Accountability, and Harm Prevention (archived in PDF and attached here for provenance).

Dashboard Demand

The September 30 agenda confirms that Los Angeles County is now operating in the BCCP Era. Yet these transformations continue without attribution, ADA inclusion, or fidelity safeguards. As a minimum condition for lawful and ethical implementation, I respectfully request the Board to publish a Convergence Dashboard documenting:

- 1. The specific policies and program changes since April 10, 2025 that reflect BCCPTM/B2C3ATM logics.
- 2. The provenance of those changes, including frameworks and public warnings they derive from.
- 3. Whether attribution, ADA/FEHA compliance, and fidelity safeguards were met.

This dashboard is essential for transparency, public trust, and historic accountability.

Agenda Highlights

- Item 8 (PQA Awards): \$147M in reported efficiency gains align with BCCPTM/B2C3ATM's equity–efficiency logics. Supervisor Horvath herself described the \$50M Measure J/G error as a "bureaucratic disaster" an error only corrected after BCCPTM was entered into the record.
- Item 14 (Domestic Violence Awareness/Prevention): Mirrors BCCPTM's care-to-custody disruption logic and B2C3ATM's survivor-centered pathways.

- Item 16 (Creative Strategist): Embedding strategist roles parallels the Systems Equity Strategist designation filed under BCCPTM/B2C3ATM. Without safeguards, this risks governance identity crisis.
- Item 21 (Urban Natureways): Interdepartmental navigation and planning logic directly align with BCCPTM prevention standards and B2C3ATM's universal navigation model.
- Item 48 (Public Health Emergencies Reserve Fund): Reframes health as foundational to safety a trauma-informed systems logic central to BCCPTM.

Closing

I ask that this comment be docketed into the Sept. 30, 2025 record, with attachments preserved. These agenda items confirm convergence. What remains unresolved is attribution, ADA/FEHA compliance, and fidelity safeguards. Without a Convergence Dashboard, the County risks institutionalizing reform without integrity.
