The Los Angeles Food Policy Council (LAFPC). The Los Angeles Food Policy Council is a collective impact organization focused on ensuring food is healthy, affordable, accessible, sustainable and fair for Angelenos by working at the intersection of food and nutrition, economic development and environmental sustainability. Nourishing the 10 million people of our county with local, culturally relevant food is the vision we aspire to. This includes viewing food as a basic, fundamental human right. Meeting the needs of those most impacted by our food system requires a strong and consistent safety net. Federal changes have disrupted and in some cases dismantled core safety net programs. Changes through the budget reconciliation bill H.R. 1 to the Supplemental Nutrition Assistance Program (SNAP) aim to impose harsh work requirements on seniors, people with dependents and explicitly excludes refugees, asylees and others from eligibility. This comes at a time when 1 out of 4 Angelenos is struggling to feed themselves and their families (USC, 2024). Additionally, effective September 30, 2025 the SNAP-Ed (Calfresh Healthy Living) program has been terminated as it was defunded in H.R. 1 This federal decision ends over three decades of evidenced-based nutrition security programming. Locally, this means a loss of over \$14 million to support over 18 partner organizations across health care clinics, K-12 schools, early education providers and food distributions to implement food insecurity screenings, healthy food pantries, food distributions and nutrition and physical activity health education.  We urge the County to explore all possible avenues to support food security initiatives through CFCI funding, existing measures and future revenue generating opportunities. Thank you.

63.		Favor	Dawn T Franks	My name is Dawn Franks. I am the Executive Director of Stewards' Village of Collaboration.I am a Year 1 grantee under the Pretrial Services Family Reunification category. I submitted a proposal for \$300,000 and was awarded \$124,000 per year. That cut made a significant difference in the service that could have been provided, particularly with our unique program for criminal justice advocacy education. We provide advocacy education to individuals and families impacted by the criminal justice system, in addition to establishing prison ministries at churches to serve their communities with resources and family support. With our advocacy education services, we help clients understand legal terminology and the processes involved in their indictment or post-sentence proceedings for family reunification.  With the funding coming to an end, my clients, who I am working with that have been in prison since their youth, will not have our services to help them with their legal cases in applying for clemency or preparing to go before the parole board. Our clients have had some negative experiences being left in limbo due to negligent legal representation that has failed to represent them in their legal matters effectively, and our advocacy is making a difference in helping them return home. The appeals they are filing are coming back in their favor.  Stewards' work is essential to our clients, and we want to continue providing the much-needed advocacy and education to support their efforts to return home. This funding is specifically for our communities that the systemic disparities of the Los Angeles County carceral system have impacted. Therefore, I ask that the board of supervisors vote in favor of continuing Year 1's funding. Thank you. Dawn Franks

I'm here today to speak on the Supplemental Budget and to demand that our public dollars reflect the values of justice, care, and true community investment. I oppose this budget as it stands and urge you to commit to a "care first, jails last" agenda.  In my worker at CHPLA, a CFCI recipient. I see firsthand the impact that Intensive Case Management Services and permanent housing have on our community. When I first started, 70% of my caseload was unhoused, many of whom faced this obstacle for five or more years. Through the FHSP voucher and Motel Program, I was able to help all clients finally obtain permanent housing. CHPLA LEAD program provides them with this support. We cannot have people waiting for years to be matched with a voucher. This is life or death circumstances. Anticipated impacts of the 23% cut in staff positions and the reassignment of our Commission PIO:

- 1) The countywide anti-hate program, LA vs Hate, a top ten PQA award winner, would lose 1/3 of its team of 3 SrHRCs.
- 2) The widely recognized and respected HRC report on hate crimes and incidents would lose 1/3 of its team of 3 SrHRCs.

And all of this is occurring at a time when:

- Federal actions are fueling widespread discrimination against Latinos (targeting based on racial/ethnic and other stereotypes about undocumented immigrants) as well as the other groups most targeted by hate (Blacks, Latinos, Jews, LGBTQ+, Asians, etc.)
- Our latest data shows exceptionally high levels of hate activity in LA County (both hate crimes, hate incidents, bullying, harassment, and other acts of intentional discrimination, etc.)
- We are continuing to ramp up LA vs Hate's Signs of Solidarity campaign in LA County zip codes with high numbers of reported hate acts against the most targeted groups.
- The loss of the SrHRC positions with the least seniority (most recently hired) would cut the anti-hate bystander training expert when needed most.
- A huge part of our success in raising awareness about getting free services for victims of hate acts in LA County is due to LA vs Hate and also our PIO.

Impacts of staff cuts:

- The 23% cut to the LA vs Hate staff team will seriously weaken LA vs Hate's ability to serve tens of thousands who report discrimination and hate due to federal actions and the ripple effect it has on the larger population. Given the massive increase in the federal budget for immigration enforcement that was passed for this current federal FY starting October 1st, what occurred in June (until the injunction) will likely be dwarfed by what will happen to LA County with the huge expansion in funding for more federal agents and detention facilities.
- The elimination of 2 staff positions will hamper the Commission's ability to expand anti-hate bystander trainings, which enable community members to help others who they observe being subjected to discriminatory and biasmotivated actions by others (including those acting under color of law, a violation of California civil rights laws)
- The commission will potentially suffer a major loss to the Commission's training capacity (by 33% 1 of 3 trainers) to building effectiveness for our community-based organizations (CBOs) that are part of our LA vs Hate Rapid Response Network and Stop the Hate networks serving LA county. (Contractually mandated to receive anti-Black racism, anti-hate bystander training, etc.)

Possible solution that still meets the goals of countywide curtailment: The Commission staff have identified S&S funds equivalent to the

\$857,903.02 reduction in S&EB resulting from the 5 positions slated to be cut. While this represents a serious reduction in resources, it would not have the crippling impact of the proposed drastic cuts to Commission staffing. The S&S funding reduction identified would not interfere with Measure B funds already approved and allocated to provide the S&S for two of three major contracts for our LA vs Hate system: Hate Reporting and Victim Support System (with 211LA) and the Rapid Response Network of trusted CBOs who partner to support victims and engage in effective hate response/prevention actions. - **21** youth placed in their first-ever paid internships this year through our Compton Youth Career Pathways program.
- 140 youth engaged in free summer art camp, 30 families enrolled in DiscoverU Enrichment Centers, and 15 families in Little Creators just in 2024 alone.
- **400 volunteers mobilized** to support youth and families.

These outcomes directly advance the County's Care First goals: preventing justice involvement, creating safe and supportive environments for young people, and reducing long-term costs tied to incarceration, unemployment, and homelessness.



Creating pathways to college, employment and entrepreneurship for Compton youth through engagement with STEM education and the arts.

CFCI is not about unspent funds—it is about building lasting capacity for communities that have been historically disinvested in. Redirecting funds would disrupt fragile progress and send a signal that voter mandates and equity commitments can be set aside.

Dear Los Angeles County Board of Supervisors,

My name is Andony Corleto. I am a program associate from Vera California, a local initiative of the Vera Institute of Justice, which is a national organization working to end mass incarceration, protect immigrants' rights, and build safe, thriving communities. I am also a resident of District 2.

It is important that Los Angeles County remains committed to the "care first, jails last" vision as our north star, especially as our community members are continuing to die <u>inside county jails</u> without the care and services they need. The majority of Los Angeles's jail population is being <u>held pretrial</u>, even though many are <u>considered appropriate candidates for diversion</u>. Promising data also suggests care-first programs are <u>three times more effective</u> at reducing recidivism than incarceration, making these investments both urgent and necessary.

Our budget should reflect the issues the Board has chosen as priorities:

- Closing of Men's Central Jail without building a replacement facility
- Funding mental health care for people post-release from LA County jail
- Investing in pre-trial and reentry non-custodial services and treatment
- Restoring full funding for staffing and resources previously cut from Public Defense
- Staffing the departments and workforce to help LA County meet its decarceration and diversion goals

We also must increase the transparency and accountability for <u>Care First Community Investment</u> (CFCI) funding. Community members fought for <u>Measure J.</u> and they deserve to



know how these funds are being used through regular reporting, clear spending plans, and timely implementation.

I thank the supervisors for their time and ask that you all allocate budget funds into Carefirst programs that provide proven solutions to reduce recidivism and build safer, stronger communities.
