Landlords will find loopholes to evict people in the most vulnerable situations right now.</p> <p>Requiring attestation to "fit" into a narrow eviction moratorium" will create a dangerous situation where tenants essentially must disclose their immigration status to their landlords, even though landlords normally are prohibited from asking for that information. By requiring landlords to demand attestation before applying protections, the Board may also be exposing landlords to increased liability under FEHA and AB 291.</p> <p>Furthermore, because ICE continues to conduct raids at LA courthouses, it is imperative that other no-fault evictions also be banned to reduce the instances in which immigrant tenants are forced to go to court.</p>

24.		<b>Favor</b>	Scott Garvey	<p>I am writing to express my strong support for Agenda Item 24, scheduled for verbal report and discussion on October 7, 2025, which explores options for implementing eviction protections across Los Angeles County in response to immigration enforcement actions and related disruptions.</p> <p>This proposal is both timely and necessary. Immigration raids can have devastating ripple effects on families and communities, often resulting in sudden income loss, trauma, and displacement. Without safeguards, these disruptions can lead to unjust evictions, increased homelessness, and further marginalization of vulnerable residents.</p> <p>Los Angeles County has long been a leader in promoting equity, inclusion, and public welfare. Enacting eviction protections in the wake of immigration raids would:</p> <ol style="list-style-type: none"><li>1. Prevent homelessness among families affected by enforcement actions.</li><li>2. Promote community stability by allowing tenants time to recover from income loss or legal uncertainty.</li><li>3. Uphold human dignity by ensuring that no one is forced out of their home due to circumstances beyond their control.</li><li>4. Align with existing disaster-related eviction moratoriums, such as those enacted after the January 2025 wildfires.</li></ol> <p>Despite recent progress, over 72,000 people remain homeless in Los Angeles County, with nearly 50,000 unsheltered. Evictions would likely reverse the gains made in reducing homelessness, especially among vulnerable populations. The moratorium helps stabilize communities and prevents a surge in displacement during this time of crisis.</p> <p>Economic justice is also at stake. Renters in Los Angeles County must earn nearly \$50 per hour—almost three times the minimum wage—to afford the average rent of \$2,578 per month. With 485,000 low-income households lacking access to affordable housing and 79% of extremely low-income renters paying more than half their income on rent, the moratorium provides critical breathing room.</p> <p>The moratorium includes legal safeguards, requiring tenants to self-certify hardship under penalty of perjury and begin income replacement efforts. Landlords retain the right to challenge fraudulent claims, ensuring a fair balance between tenant protection and property rights.</p> <p>Additionally, the County's approval of \$30 million in rent relief, offering up to \$15,000 per household for wildfire and ICE raid survivors, demonstrates a commitment to coordinated relief efforts. Eviction protections work in tandem with financial assistance, ensuring families aren't left vulnerable while awaiting aid.</p> <p>I respectfully urge the Board to maintain and enforce the current eviction moratorium through its full duration, ensure equitable and efficient distribution of rental assistance funds, and explore additional protections for vulnerable populations.</p> <p>Thank you for your leadership and commitment to protecting the residents of Los Angeles County during this challenging time.</p> <p>Sincerely, Scott Garvey</p>

**Support for Agenda Item 24 – Eviction Protections in Response to Immigration Raids and Related Disruptions**

Dear Members of the Board of Supervisors,

I am writing to express my strong support for Agenda Item 24, scheduled for verbal report and discussion on October 7, 2025, which explores options for implementing eviction protections across Los Angeles County in response to immigration enforcement actions and related disruptions.

This proposal is both timely and necessary. Immigration raids can have devastating ripple effects on families and communities, often resulting in sudden income loss, trauma, and displacement. Without safeguards, these disruptions can lead to unjust evictions, increased homelessness, and further marginalization of vulnerable residents.

Los Angeles County has long been a leader in promoting equity, inclusion, and public welfare. Enacting eviction protections in the wake of immigration raids would:

1. **Prevent homelessness** among families affected by enforcement actions.
2. **Promote community stability** by allowing tenants time to recover from income loss or legal uncertainty.
3. **Uphold human dignity** by ensuring that no one is forced out of their home due to circumstances beyond their control.
4. **Align with existing disaster-related eviction moratoriums**, such as those enacted after the January 2025 wildfires.

Despite recent progress, over 72,000 people remain homeless in Los Angeles County, with nearly 50,000 unsheltered. Evictions would likely reverse the gains made in

reducing homelessness, especially among vulnerable populations. The moratorium helps stabilize communities and prevents a surge in displacement during this time of crisis.

Economic justice is also at stake. Renters in Los Angeles County must earn nearly \$50 per hour—almost three times the minimum wage—to afford the average rent of \$2,578 per month. With 485,000 low-income households lacking access to affordable housing and 79% of extremely low-income renters paying more than half their income on rent, the moratorium provides critical breathing room.

The moratorium includes legal safeguards, requiring tenants to self-certify hardship under penalty of perjury and begin income replacement efforts. Landlords retain the right to challenge fraudulent claims, ensuring a fair balance between tenant protection and property rights.

Additionally, the County's approval of \$30 million in rent relief, offering up to \$15,000 per household for wildfire and ICE raid survivors, demonstrates a commitment to coordinated relief efforts. Eviction protections work in tandem with financial assistance, ensuring families aren't left vulnerable while awaiting aid.

I respectfully urge the Board to maintain and enforce the current eviction moratorium through its full duration, ensure equitable and efficient distribution of rental assistance funds, and explore additional protections for vulnerable populations.

Thank you for your leadership and commitment to protecting the residents of Los Angeles County during this challenging time.

I am submitting this comment on behalf of the Sunita Jain Anti-Trafficking Initiative (SJI), an organization that develops and advocates for policies to prevent human trafficking and support survivors.

I want to voice strong support for a County eviction moratorium, particularly for residents impacted by recent wildfires and federal immigration enforcement actions. This moratorium is not only a housing stability measure, it is also a critical trafficking prevention tool.

We've seen again and again that housing instability is one of the strongest predictors of trafficking risk. When people lose their homes or face sudden income loss, they become targets for traffickers offering false promises of work, housing, or safety.

This is especially true for immigrant families, low-income renters, and survivors, who are now at greater risk because of these overlapping crises. Without immediate protection from eviction, many will be forced into unsafe situations such, as couch-surfing, working informally, or entering exploitative labor or housing arrangements just to survive.

A moratorium would help break the cycle that puts people at risk. It gives families time to recover, get rental support, and stay housed without fear. This is about safety as much as housing, and it supports the County's work to prevent trafficking and help survivors.

I urge the Board to move quickly on this moratorium and ensure the inclusion of targeted outreach and protections for communities most at risk of trafficking, including undocumented workers, disaster survivors, and low-wage renters.

Thank you for your leadership in making sure no Angeleno is pushed from their home into harm's way.
